## Office Order

Whereas, the report of Comptroller and Auditor General received through Director Environment, Haryana vide letter dated 02.05.2017 and 30.05.2017 intimating that the HSPCB has neither conducted survey nor evolved any monitoring mechanism to ensure that the industries should not operate without obtaining consent to establish (CTE)/ consent to operate (CTO) under Water Act, 1974 and Air Act, 1981 and environmental clearance under EIA notification dated 14.09.2006, which is clear from the fact that closed/sealed units by the Board were found in operation during the physical verification of the sealed / closed units by the team of Comptroller and Auditor General (Audit);

Whereas, some of the Regional Officers are submitting the request to Head Office for grant of permission for re-sealing of those units which were closed and sealed by the Board but found broken the seal and/or operating illegally in violation of closure orders issued by the Board under various Environmental Acts;

Whereas, the matter was placed before the Technical Advisory Committee (TAC) of the Board in its meeting held on 10.08.2017, 09.10.2017 & 16.11.2017 which has been examined by the TAC and recommendations submitted by the TAC has been accepted and approved which were circulated vide Head Office letter no. HSPCB/TAC/2018/99-110 dated 16.01.2018.

In view of above and recommendations of TAC, it is hereby ordered that no permission of head office will be required to re-seal the units which were closed and sealed by the Board but found broken the seal and/or operating illegally in violation of closure orders issued by the Board under various Environmental Acts and Regional Office shall reseal such units at their level in reference to the standing closure orders after following the due procedure and collecting the necessary evidence to prove the violation made by such unit for filing a proper prosecution case against such units and persons responsible for its day to day working. Further it is also ordered that, to check the actual status of closure of such units which have been closed/sealed by the Board under various Environmental Acts and to check the illegal operation of such units, the Regional Officers/concerned field officers will inspect such units regularly and submit the report of such units closed/sealed by the Board and closure order has not been suspended, on monthly basis to concerned Branch Incharge in Head Office on the performa given at Annexure-I. No permission will be required for conducting inspection of such type of illegal units as provided in the inspection policy of the Board

These orders shall come into force with immediate effect.
