Whereas the Board notified the procedure for obtaining consent to establish and consent to operate and authorization under Water (Prevention & Control of pollution) Act, 1974, Air (Prevention & Control of pollution) Act, 1981 and Hazardous Waste (Management Handling) Rules, 2008 on 15.04.2014.

Whereas as per the procedure, the industrial units/projects are required to apply for the expiry of consent o operate under the above said Acts/Rules before 90 days of the expiry the period of consent/authorization granted.

Whereas final opportunity upto 15.05.2014 was given to the industrial units/projects apply for consent to operate under the above said Acts/Rules through public notice ablished in the leading news papers.

Whereas the matter was examined by the TAC (Policy) in its meeting held on \$1.08.2014.

Whereas the recommendations of the TAC (Policy) were circulated vide letter no. RSPCB/2014/625-29 dated 21.08.2014 after the approval and is reproduced as under:-
