Further, an alert through SMS will also be sent on the registered mobile number of the unit regarding issuance of show cause notice. However, in case of failure to serve the show cause notice through E-mail, Regional Officer shall serve show cause notice to the unit through registered post with AD and in case of failure to serve the show cause notice through registered post, Regional Officer shall serve Show Cause Notice through special messenger and by pasting the show cause notice on gate/premises of the unit.

> In case show cause notice is to be issued to the unit who have not obtained CTE/CTO from board, Regional Officers shall serve show cause notice to the unit through registered post with AD and in case of failure to serve the show cause notice through registered post, Regional Officer shall serve show cause notice through special messenger and by pasting the show cause notice on gate/premises of the unit.

This order shall come into force with immediate effect.
