We, M/s BenQ India Pvt. Ltd. being the producer of EEE as per E-Waste (Management) Rules, 2016, we are pleased to submit our detailed EPR plan. As per the new E-Waste (Management) Rules, 2016 we have taken various steps to implement the same as per guidelines issued by CPCB. We hereby submit our EPR plan having details about general scheme of collection, channelization plan, RoHS & Awareness Compliance.

### Brief on General Scheme of Collection:

The e-waste generated out of the products placed in the country is being collected through dealers/service centre spread out in all corners of the country. The entire lot of e-waste is warehoused at a central location in Delhi in the premises owned by an authorised service centre of BenQ.

**We, M/s BenQ India Pvt. Ltd.** collecting e-waste from the defective/obsolete and end of life products will be channelized through our PAN India Service Centre network of **M/s F1 Info Solutions Pvt. Ltd.** E-Waste collected at all service centres across India will be transporting to our centralised e-waste collection centre **M/s Perfect Enterprises** in Delhi. From **M/s Perfect Enterprises**, entire e-waste will be handed over to our e-waste authorised dismantler/recycler i.e. **M/s 3R Recycler** for recycling.

We are collecting e-waste from every part of India. Collection/points are present in 25 states. For the remaining states, have made arrangement either through reverse logistics or collection points. We opened collection centres at Arunachal Pradesh, Nagaland, Manipur, Mizoram, Tripura, Lakshadweep, Daman & Diu and Dadar & Nagar Haveli.

### Special Collection Schemes:

The general scheme for collection (Buyback, Exchange, DRS) shall be undertaken by recycler **M/s 3R Recycler**.

### Awareness Plan:

**We, M/s BenQ India Pvt. Ltd.** will conduct awareness program with respect to environmental protection from Hazardous effect of E-Waste in first phase of three years as below:

2. The bulk consumers/individual consumers will be informed to return the obsolete product to the respective dealer/service centre the list of which will be displayed on our website also and on the banner.

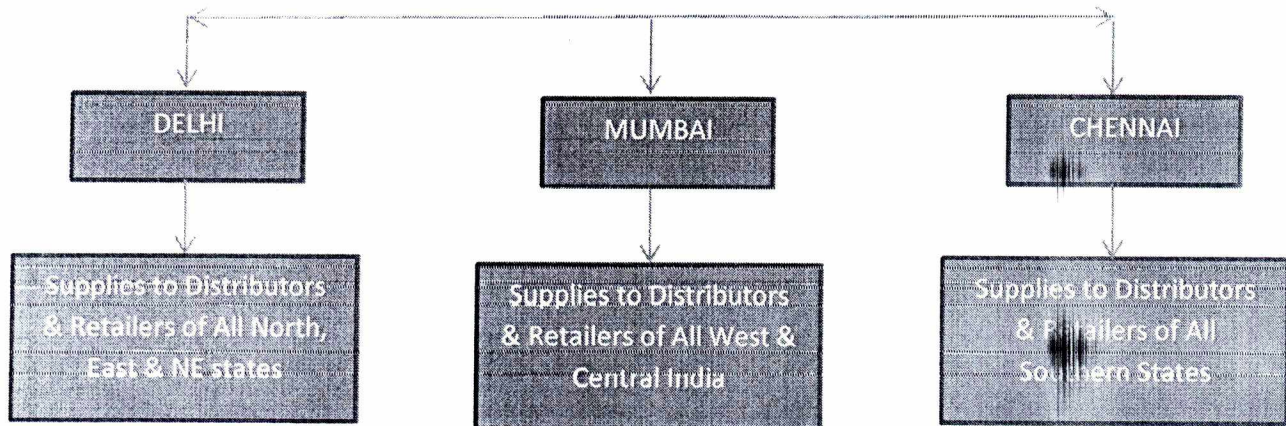
BenQ proposes to introduce an incentive schemes in case of return of the old/junk product against the purchase of new one.

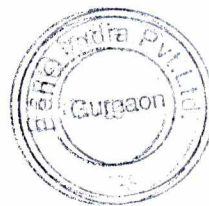
## FLOW CHART OF BENQ PRODUCTS EX-FACTORY TILL RECYCLER

BenQ Product (LCD Monitors) Manufactured in China are exported to BenQ India and shipped to their third party logistics & warehousing partner-M/S ProConnect Supply Chain Solutions Ltd.



All faulty machines of end users are being sent to BenQ authorised service centres across India outsourced through F1 Info Solutions and service PVT Ltd

After servicing of the machines, rejected & scrapped parts of LCD Monitors are sent to Perfect Enterprises Delhi (Centralised E-Waste Collection Centre ) for disposal by authorised recycler-M/S SIMS Recycle Solution India Pvt Ltd under an agreement.
