Minutes of 3<sup>rd</sup> Meeting of State Level Advisory Committee constituted under Bio Medical Waste Rules, 2016, held at 1100 Hrs on 26.03.2019.

The 3<sup>rd</sup> meeting of State Level Advisory Committee (SLAC) of Haryana constituted under the Bio Medical Waste Management (BMWM) Rules, 2016 was held under the Chairmanship of Sh. Rajeev Arora, IAS, Additional Chief Secretary to Government of Haryana, Health Department at 1100 Hrs on 26,03,2019 at Conference Room of New Secretariat, Sector-17, Chandigarh, The list of participants is enclosed at Annexure-A.

Chairman welcomed all the participants and briefly explained the objective of the meeting and Member Secretary, Haryana State Pollution Control Board (HSPCB) explained the details of the main agenda item, i.e., review of the recommendations submitted by the Committee constituted by SLAC in its 2<sup>nd</sup> meeting convened on 07.03.2019, to study the issues relating to existing system of charging of fees by Common Bio Medical Waste Treatment Facilities (CBWTFs) from Health Care Facilities (HCFs) and to recommend specific/uniform rates to be charged by CBWTFs in the State.

Member Secretary, HSPCB submitted the report prepared by the Committee to all the Members (enclosed at Annexure-B) and explained the methodology adopted by the Committee for studying the existing system in the State, capacity of existing CBWTFs, number of HCFs and beds each CBWTFs is presently catering to and the proposed changes in redistribution of HCFs among existing CBWTFs and rate slabs for different category of HCFs. He further explained the logic of redistribution of HCFs and also shared the major points of discussion held during the series of Committee's meetings held in the previous couple of weeks. He also explained that the Committee could not consider the cost of bar-coding in the present proposal as this has to be finalized yet among CBWTFs, HCFs and software system providers. Chairman after going through the report of the Committee, opened the forum for discussion. While all other members broadly agreed to the recommendations of the report, the representative member of CBWTFs objected to both the recommendations. He informed that no CBWTF is willing to redistribute the existing HCFs among themselves as they are running with their optimum capacity. But this

was refuted by Member Secretary, HSPCB indicating their representation given to the Government that all are operating well under their capacity, based on which (also), the decision to prohibit establishment of new CBWTFs in the State was taken by the Government. Member Secretary, HSPCB further informed that it has been clearly indicated in the report that all the 11 CBWTFs are operating with similar capacity and one facility operating with four times of beds/waste than the other cannot be justified logically.

The CBWTF's representative further objected to the rates proposed by the Committee informing that the transportation cost and the cost of plastic bags have not been considered in a justifiable way in the report. Member Secretary, HSPCB informed that the cost has been worked out taking into account the inputs made available to the Committee on the cost of plastic bags, transportation and the distance of PHCs located in the State.

Chairman after observing the claims of CBWTF representatives, directed that the CBWTF Association may go through the report thoroughly and submit its proposal to the Committee constituted by SLAC for its consideration. The SLAC further decided that the Committee constituted by it in 2<sup>nd</sup> meeting on 07.03.2019 shall finalize all the issues with the stakeholders and they are being delegated with the powers to summon any record and evidence on behalf of SLAC. It was decided that the Committee (constituted by SLAC) shall hold its meeting with all members and the representative of CBWTFs on 03.04.2019 and finalize its recommendations for final consideration of the SLAC.

Member Secretary, HSPCB briefly explained the directions of Hon'ble National Green Tribunal (NGT) on 'Compliance of Solid Waste Management Rules, 2016 in the State of Haryana' in OA No. 606/2018 wherein NGT has directed that the State shall comply with all the provisions of Bio Medical Waste Management Rules, 2016 in 3 major cities, towns, municipal corporations and 3 panchayats in each District in a period of six months and requested all members to ensure the compliance accordingly.

The meeting ended with thanks to all the participants.

# Report of the Committee constituted by State Level Advisory Committee of Bio Medical Waste Management

#### Introduction

The State Level Advisory Committee (SLAC), constituted by the Government of Haryana under the provisions of Bio Medical Waste Management Rules 2016, in its first meeting, held on 16.08.2018 under the Chairmanship of Shri R.R. Jowel, IAS, Additional Chief Secretary, Department of Health, Government of Haryana cum Chairman of SLAC, constituted a Committee under the Chairmanship of Director, Environment Department, Government of Haryana to study the existing system of charging of treatment fees by Common Bio Medical Waste Treatment Facilities (CBWTF) from the Health Care Facilities (HCF) and to recommend a viable, feasible and uniform rate for collection, transportation, treatment and disposal of their Bio Medical Waste in the State. An order was issued by Health Department (No 16/14/2018-3 Env dated 24.080.2018) constituting a Committee under the Chairmanship of Shri Shekar Vidyarthi, IAS, Director, Environment Department, with Director General ULB Department (or his representative not below the rank of Chief Engineer), Chief Medical Officer of Sonepat, Representative of CPCB, Representative of HSPCB and one Financial Expert to be nominated by Environment Department, as members of the Committee.

The Committee accordingly undertook a study and after examining the issues, it submitted its report to SLAC, which was reviewed by SLAC in its second meeting held on 07.03.2019. After going through the report, SLAC observed that there was no specific recommendation on the issue of rates to be charged by the CBWTF, which was the main task assigned. The matter was further discussed and the Committee was of the opinion that the rates charged by CBWTFs are not uniform (among CBWTF themselves as well as between Government and private HCFs) and this issue needs to be addressed as it often leads to confusion among HCFs and may probably lead to exploitation of HCFs. To decide the further course of action on the same, SLAC constituted another committee under the chairmanship of Member Secretary of Haryana State Pollution Control Board (HSPCB) with Additional Director General of Health Services (ADGHS), Secretary of IMA Haryana State Chapter, President of Haryana CBWTF Association and Regional Officer (RO), HSPCB, Panchkula Region, as Members with instructions to examine the issues involved and submit the recommendations by 26.03.2019, on which date the SLAC decided to meet again, specifically to discuss the same.

The official members of the above constituted Committee met in the subsequent week and co opted four more official members for getting the institutional inputs from relevant Departments. Accordingly, Sh Nirmal Kumar, RO, Yamunanagar (who was earlier dealing with BMW Management Cell of HSPCB), Sh. Satinder Pal, EE (Presently holding the charge of BMW Management Cell in HSCPB), Dr RK Chauhan, Jt Director, Environment Department (who was involved in the earlier committee) and Dr Asruddin, Director, Health Services, Haryana (who is the Nodal Officer of BMW in Health Department) have been included as part of the Committee.

# Mandate, Actions carried out and Recommendations the Committee

# (a) Proposal for Redistribution of HCFs among CBWTFs

The committee held a series of meetings and examined the facts provided by the previous committee and also discussed various physical and financial aspects detailed in its report. During its initial meetings, the Committee felt that an important issue regarding uneven distribution of HCFs among CBWTFs, requires to be addressed, without which the issue of uniform charging of rates on BMW may not be a feasible proposition. The Committee observed that the distribution of HCFs among CBWTFs varies significantly whereas the capacity of every CBWTF is more or less the same. Thus, there is no justification (other than the distance factor) to allow some CBWTFs to operate/deal with more waste and some with less. This becomes more significant, as the CPCB guidelines also insist on minimum number of beds / waste for every CBWTF to ensure economic feasibility of operation. Therefore, it was decided to include a study on the existing distribution of HCFs among CBWTFs and to recommend for any changes, if required.

For the above purpose, the location and area of operation of every CBWTF, number of beds catered, quantum of waste treated by every CBWTF, approximate area to be travelled by the CBWTFs for collection and the incineration capacity of every CBWTFs were studied among the 11 authorized CBWTFs in the State.

Upon examination, the following observations are immediately apparent.

 a) Two CBWTFs are established in District Sirsa (M/s Invision Enviro Services and M/s Surya Waste Management)

- b) Two CBWTFs (M/s Ess Kay Hygienic, Panchkula and M/s Rudraksh Envirocare, Ambala) are closely located.
- c) Two CBWTFs (M/s Vulcan Waste Management, Gurugram and M/s Golden Eagle Waste Management, Faridabad) are again closely located.
- d) No CBWTF has been established in Districts of Panipat, Sonepat, Yamuna Nagar, Kurukshetra, Kaithal, Narnaul, Rewari, Mohendergarh, Jhajjar, Palwal, Mewat, Fatehabad and Charkhi Dadri.

Again, on examination of the number of beds, a significant level of variation was observed. For instance,

- (a) Only three (of 11) CBWTFs (M/s Vulcan Waste Management (8500 beds), M/s Golden Eagle Waste Management (6700 beds) and M/s Divya Waste Management (6400 beds)) are catering to more than 40% of the total beds.
- (b) On the other hand some of the CBWTFs are catering beds as low as 1900 beds (M/s Surya Waste Management).

Further, an observable variation in the quantum of waste collected and disposed by each CBWTFs was noticed, which varies from 126 Kg /day (in M/s Surya Waste Management) to 4050 Kg/day (in M/s Vulcan Waste Management). It was also observed that the concentration of HCFs are quite high in the Districts of Gurugram, Faridabad, Hisar and Rewari, compared to rest of the State.

The Committee, after considering the above facts, and the following, i.e.,

- (i) the underlying principle of economic feasibility of CBWTFs' operation, as emphasized in CPCB's guidelines;
- (ii) the fact that all the CBWTFs in the State have a similar capacity and all are claiming to have been operated below their actual capacity; and,
- (iii) the fact that the present operational areas have been demarcated by the CBWTFs among themselves,

proposes that there is a requirement of re-distribution of beds (HCFs) among CBWTFs, and the same has been proposed after due deliberations, as indicated at **Annex I** for consideration of SLAC for implementation.

The above proposal was not agreeable to the Member representative of CBWTF who wished that the status quo should continue without any disturbance as it may create inconvenience to some CBWTFs. In this regard, it is also informed that though the Committee tried its best to evolve an even distribution proposition, it was not done due to certain reasons, like geographical position of CBWTFs and non-availability of CBWTF in some areas. For instance, M/s Golden Eagle Waste Management which is catering to 6700 beds where no change has been proposed as it does not have any other adjoining CBWTF treating lower number of beds. Similar constraint is observed in case of M/s Vulcan Waste Management which is already catering to 8500 beds and has been proposed for a reduced number of 6800 beds, but could not be reduced further due to non-availability of any CBWTF nearby. However, it may be kept in mind that as per CPCB guidelines, a CBWTF can cater to 10,000 beds and this recommendation is being proposed to facilitate even distribution among existing CBWTFs to ensure economic viability of all the facilities.

### (b) Proposal on waste treatment charges

The Committee studied the quantum of waste being treated by all CBWTFs, based on the number of beds in the State, which works out to be around 12,500 Kg (app 12.5 MTs) per day. The installed capacity of all CBWTFs as observed by Environment Department (vide its order No. 16/17/2016-3 Env dated 18/07/16) is around 55.6 MT. However, as per the details available with HSPCB, every facility has an approximate incineration capacity of 150 Kg/Hr (which works out to be around 13,200 Kg (for all 11 CBWTFs considering an average operation of 8 hours per day). Rates prevailing in Punjab and Delhi were also studied by the Committee.

Presently, the rates charged by different CBWTFs are different in their own jurisdiction and it is observed that they are charging differential rates between Government and private HCFs. It was claimed by the representative Member of CBWTF that since Government HCFs, especially PHCs and CHCs, are located at quite a distance from District Head Quarters, there is a reason for charging a higher rate from them compared to private HCFs to compensate the transport cost. DGHS has worked out the rates charged by CBWTFs from HCFs and the same is enclosed at **Annex II**.

Upon deliberation on the cost charged by different CBWTFs, the Committee worked out a rate for different categories of HCFs, i.e., facilities / Establishments without beds, facilities with 1-5 beds, 6-10 beds, 11-20 beds, 21-30 beds, 31-50 beds, 51 to 100 beds and facilities having more than 100 beds. The slabs have

been deliberately kept at close intervals till 50 beds to ensure that smaller facilities do not get affected by clubbing them with bigger facilities. This proposal was presented (Annex III) and discussed with all the Committee members on 20.03.2019, where the Representative Members of CBWTFs strongly refuted the proposal informing that the 'proposed rates cannot meet the CBWTF treatment requirements financially', and they insisted that differential rates should be maintained as the HCFs are located at different locations and thus require their transportation cost be included in the process. They also insisted that the cost of disposal bags should also be not included in the proposal as the cost of the bags as per revised standards are much higher compared to earlier provisions. They were requested to send a detailed proposal on the rates after consulting other CBWTFs as well and they accordingly sent a proposal, which may be seen at Annex IV.

The official members of the Committee again met on 25.03.2019 and considered the proposal of CBWTF Association. After detailed discussion on the present rates, proposed rates and the one suggested by CBWTF Association, the Committee was of the opinion that the disposal bags must be included in the rates and further considering the proposal of CBWTFs, the following charges have been proposed for treatment of BMW for different category of HCFs, as below.

Specification of facilities	Rates proposed
Facilities without Beds	Rs. 850/month (including disposal bags)
Facilities upto 5 beds	Rs. 1000/month (including disposal bags)
Facilities from 6-10 beds	Rs. 1750/month (including disposal bags)
Facilities from 11-20 beds	Rs. 2250/month (including disposal bags)
Facilities from 21-30 beds	Rs.3000/month (including disposal bags)
Facilities from 31-50 beds	Rs. 4500/month (including disposal bags)
Facilities from 51-100 beds	Rs. 7000/month (including disposal bags)
All facilities with more than 100 beds	Rs. 6 per bed per day (including disposal bags)

Considering the distance factor involved in collection of waste from PHCs and CHCs, it is recommended that a fixed additional amount of Rs.2,000/- per facility per month may be provided by Government PHCs/CHCs to compensate the transportation charges.

The Committee therefore recommends the above two proposals, one on the re distribution of HCFs among CBWTFs (as proposed at Annex I) and the rates for treatment of waste for different categories of HCFs, as above, for the consideration of State Level Advisory Committee constituted for implementation of Bio Medical Waste Management Rules 2016 in Haryana.
