**Minutes of 6th Meeting of State Level Advisory Committee constituted under Bio Medical Waste Management Rules, 2016 held at 1200 Hrs on 19.01.2021.**

The 6<sup>th</sup> meeting of State Level Advisory Committee (SLAC) of Haryana constituted under the Bio Medical Waste Management (BMWM) Rules, 2016 was held under the Chairmanship of Sh. Rajeev Arora, IAS, Additional Chief Secretary to Government of Haryana, Health Department cum Chairman SLAC at 1200 Hrs on 19.01.2021 in Conference Room of HSPCB, C-11, Sec-6, Panchkula. The list of participants is enclosed at **Annexure-A**.


Chairman welcomed all the participants and Member Secretary, Haryana State Pollution Control Board (HSPCB) cum MS SLAC briefly explained the agenda items for discussion in the meeting. The proceedings of the meeting and decisions taken along are as below.

**Agenda Item No. 1: Confirmation of minutes of 5<sup>th</sup> SLAC meeting.**

The minutes of the 5th meeting of SLAC held on 23.07.2020, which were circulated on 30.07.2020 to all the members, were confirmed.

**Agenda Item No. 2: Taking decision on the recommendation of the committee constituted by SLAC under the Chairmanship of MD, NHM regarding representation of area distribution among CBWTFs**

- SLAC constituted a Committee on 27.10.2020, under the Chairmanship of MD, NHM with Members from DGHS, HSPCB & IMA to examine the representation of CBWTFs within a month.
- The Committee reviewed the representation of CBWTFs in its meeting held on 02.11.2020 and key recommendations of the Committee are as under.
- M/s Surya Waste Management shall operate with 2917 beds with its jurisdiction over the Government & Private Hospitals of Sirsa Distt and Government Hospitals of Fatehabad Distt.
- M/s Invision Enviro Services shall operate with 2956 beds with jurisdiction over the Government and Private Hospitals of Kaithal Distt and Private Hospitals of Fatehabad Distt.
- The area of rest of 9 CBWTFs may not be changed and the area distribution among all remaining CBWTFs will remain the same as it was, before the redistribution order dated 10.08.2020.
- The policy of HSPCB regarding catering to an area within 75 Km radius of CBWTFs may be strictly adhered to.

The above recommendation of the Committee is placed before the SLAC for deliberation and taking final decision. After discussion on the recommendation of sub-committee, the Committee accepted the same and directed to issue the orders in this regard.

**Agenda Item No. 3: Review of status regarding compliance of Bio Medical Waste Management during COVID-19 period in Haryana**

The Committee was apprised of the case pending in National Green Tribunal i.e. OA no. 72/2020 (Scientific Disposal of BMW arising out of COVID 19 Treatment). The progress regarding creation of awareness among waste handlers, workers and citizens through online training, public notices, posters for the hospitals etc, implementation of centralized tracking software of CPCB and preparation of model plan for management at Panchayat, sub divisions and district levels considering local conditions were briefly explained to the Committee by HSPCB and Health Department.

After discussion it is decided that a DO letter be issued on behalf of Chairman SLAC to the Chairman of District Level Monitoring Committees for finalization of the model plan for management of the Covid-19 bio medical waste at vill. Panchayat, sub-division and district level in compliance of NGT orders dated 24.04.2020.

**Agenda Item No. 4: Status of compliance of obtaining authorization under BMW by Veterinary Hospitals**

The Committee was apprised of the status regarding authorization obtained by different Veterinary Hospitals/Dispensaries in the State and the compliance is not found satisfactory w.r.t. the provisions of BMWM Rules, 2016.

Dr. Sukhdev Rathi, Deputy Director, Animal Husbandry informed that there are approximately 1000 hospitals and 2800 dispensaries in the State and due to limited budget provisions it is not practically viable by the department to make huge investment for doing agreement with CBWTFs for management of veterinary bio medical waste. He further informed that the bio medical waste being generated from veterinary dispensaries etc. is negligible. After discussion on the said issue, Chairman, SLAC decided that a Sub-Committee be constituted under the Chairmanship of Member Secretary, HSPCB cum SLAC, with member Director Health Services, DG, Animal Husbandry, Sr. EE (SWM), RO Panchkula, HSPCB and Representative of CBWTFs to assess the nature and quantum of bio medical waste being generated from veterinary

hospitals/dispensaries, to suggest alternate technology/mechanism for treatment and disposal of veterinary bio medical waste and also to propose separate rate if required, to be charged by CBWTFs for management of veterinary bio medical waste.

#### **Agenda Item No. 5: Status of Compliance of Bar code system**

HSPCB informed that a sub-committee has been constituted vide order no. Endst./HSPCB/BMW-91/2020/9768-82 dated 11.08.2020 in-compliance of minutes of SLAC meeting held on 23.07.2020.

HSPCB, further informed that the information regarding draft tender document/terms & conditions has been sought from different private vendors and also collected from the website of different pollution control boards. It is further informed that Andhra Pradesh Pollution Control Board (APPCB) has already issued the tender in this regard and the inputs has been taken from the same for preparation of the draft tender document for State of Haryana. HSPCB is further modifying the draft tender document and the same will be completed shortly and accordingly a meeting will be convened of the sub-committee for further discussions and finalization of the tender document.

After discussion, Chairman SLAC directed that the draft tender document should be framed as soon as possible and be finalized & floated on priority basis.

#### **Agenda Item No. 6: other points discussed in the meeting.**

- Representative of CBWTFs raised the issue regarding revision of the rates fixed by the SLAC during 2019 for treatment of Bio Medical Waste. Chairman SLAC directed him to submit the proposal alongwith justification and documentary proofs in this regard within a week for further consideration.
- Deputy Director, Animal Husbandry raised the issue that wherever agreement has been made with CBWTF, the services given by CBWTFs are not satisfactory. The Chairman SLAC accordingly directed him to submit the issues in writing to SLAC and HSPCB.
- IMA representative submitted his written representation on which Chairman, SLAC directed to examine the same and to take further action if required.
