Status report regarding compliance with regard to Construction & Demolition Waste Management Rules 2016

Construction and Demolition (C&D) waste-disposal and handling :-

Municipal Corporation, Gurugram has established a processing plant of Construction and Demolition waste at Village Basai to treat 300 MT of C&D Waste daily and the capacity will be increased to 1500 MT shortly. Two number agencies have also been empanelled to collect and transport the C&D waste from the household's to the designated locations.

For remaining towns the status is as under:-

a. As per C&D Waste Rules 2016, all ULBs must identify separate site for C&D waste collection. At present, 79 ULBs have identified C&D sites for separate storage of construction and demolition waste. The detail of Municipalities who have identified the site for dumping of C&D waste along with the approximate quantum of C&D waste generation (Tonne per day) is as given below.

All ULBs with population approx. 5 Lakh must establish C&D waste plants to process the Construction & Demolition waste. For the establishment of C&D waste plants, following 2 cities have been selected and Bidding documents have been prepared, considering the waste quantity of 100 TPD- 250 TPD. Model Bidding documents are under consideration in CoSI meeting for approval. The bids shall be invited after the approval of bid document

- 1. Faridabad
- 2. Sonepat

A draft policy for management of Construction & Demolition waste has also been prepared by ULB department which is under consideration and will be finalized soon That the ULB Department of Haryana has issued 995 challans amounting to Rs. 93,89,900/against the non-compliance of C&D Waste management Rules-2016 during the financial year
2019-20 and ULB Department is starting an intensive drive to ensure the compliance of
Construction and Demolition Waste Management Rules-2016. MCs have also been directed to
ensure that all the contractors, builders & individuals should comply with the C&D waste
management rules and the challans on violators should be done for non-compliance.
