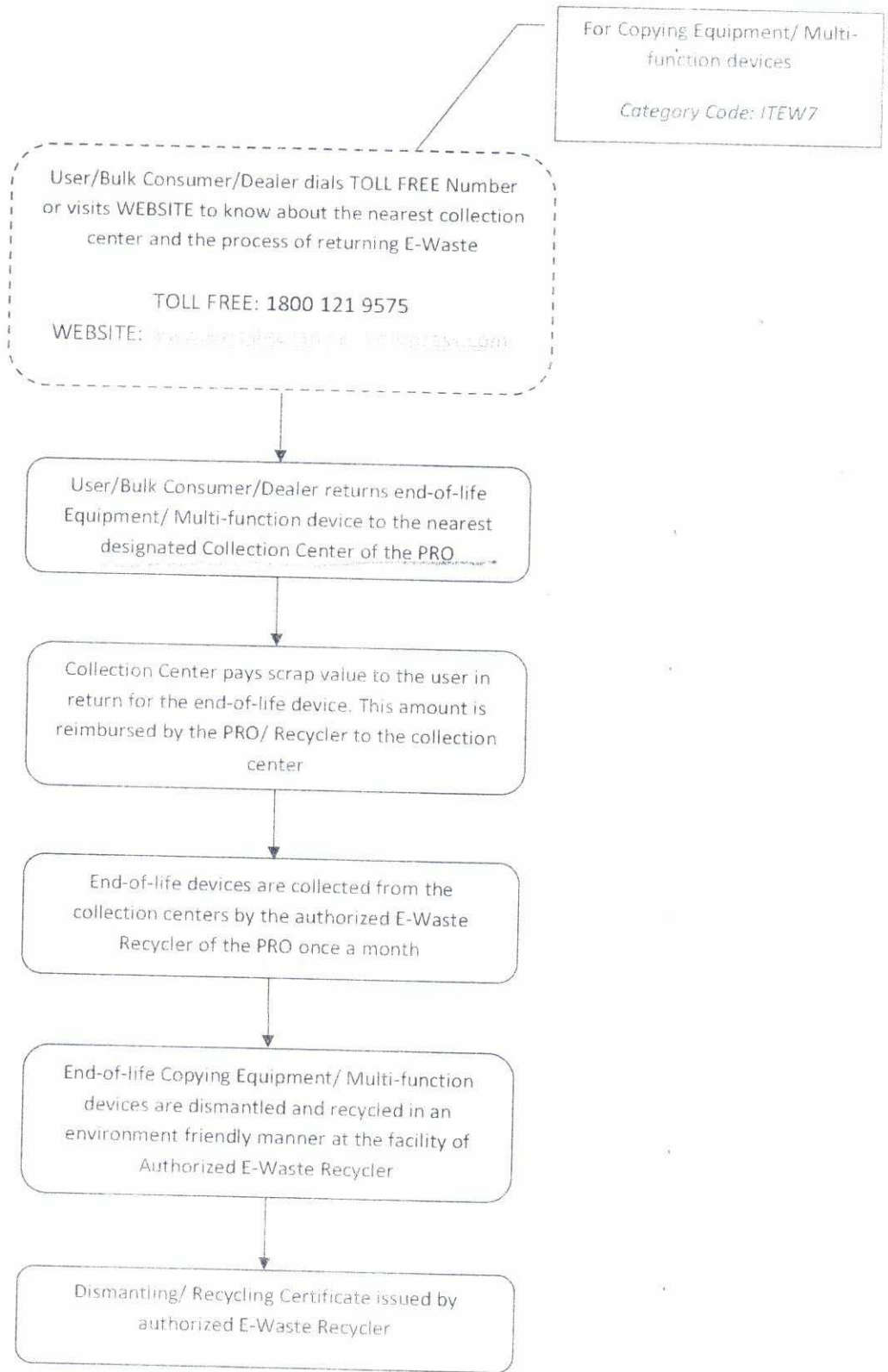

User would also be able to know about the nearest collection center and would be able to schedule the pickup through the call. Awareness programs as described in Section 7 of this EPR Plan would be undertaken to spread information about the same.

Role of PRO:

The PRO will be the central agency that will be managing the channelization of end-of-life devices of all the associated producers. The PRO has tie-ups with authorized e-waste recyclers in various States. Agreements with all allied E-Waste Recyclers (authorized by CPCB/ SPCB) are enclosed with this EPR application. Further, the list of pan-India collection centers is provided below. The operative recycling capacity of the PRO is **7000 MTA** (metric ton per annum), which also includes the recycler(s) engaged with the Producer(s) already.

Further, the PRO will also be managing a common central website and a toll-free consumer helpline for all its allied Producers.

Whether All States are covered?

All States are covered through the list of Collection Centers provided below. E-Waste from these collection centers will be channelized to the nearest E-Waste Recycling facility of the PRO.

The Producer will run a Deposit Refund Scheme along with a Buy back mechanism for ensuring effective e-waste channelization. The schemes are defined in detail below:

- a. The Producer will charge a mandatory Deposit Refund Fee ("DRF") on sale of new products to its customers. The structure of charging of DRF will be as follows:

SNo.	Sale Price of Product (in INR)	DRF (in INR)
1	Upto 25,000/-	1000/-
2	25,001/- and 50,000/-	2500/-
3	50,001/- to 1,00,000/-	5000/-
4	Greater than 1,00,000/-	10,000/-

The modalities for implementing DRF are being worked out. The details of DRF and the method of refund of the same will be explained to the customer at the time of sale of product. Further, the customer would be guided to maintain the bill of purchase to claim the amount back at the time of returning the end-of-life product.

DRF amount would be maintained by the PRO for all its associated Producers and would be refunded in full with nominal interest as determined by the PRO at the time of return. The terms and conditions of this scheme along with the calculation of nominal rate of interest will be provided on the invoice issued to the customer at the time of purchase.

- b. **Buy-Back Scheme:** This scheme, which would essentially mean buying back the end-of-life Equipment from the end user, will be run by the Producer at all designated Collection Centers/ Dealers/ Distributors. This scheme will encourage the end user to return the end-of-life devices to the dealer/ collection centre for a fair scrap value. The scrap value would be determined by the dealer upon physical evaluation of the end-of-life device. Other factors contributing to the determination of scrap price would be, including but not limited to, the age & model of the machine. The E-Waste recycler would compensate the dealer for the fair scrap price paid to the customer.

Sample Calculation of the above mentioned schemes

- i. DRF charged at the time of Sale of new product = INR 1000/-
- ii. Nominal Simple Rate of Interest on DRF = 5% per annum
- iii. Product used for = 8 years
- iv. Fair Scrap Value of end-of-life Copying Equipment/ Consumable or Spares = INR 2000/-
- v. DRF with interest component = INR 1400/-
- vi. Payback to the user by the dealer/ distributor/ collection center of the producer = INR 3400/-

- Storage of the e-waste would be done at the Dealer premises/ Collection Center in a designated area. Packaging may be used for safe handling during transportation.
- The E-waste would be collected & transported by the authorized E-Waste Recycler and thereafter dismantled.
- E-Waste Management Documentation would be maintained throughout the process in both the cases above. This would include the transportation manifests, Form-2 and disposal/destruction certificate from the authorized E-Waste Recycler.

Given below are the details of Consumer Awareness Initiatives/ Programs proposed to be undertaken by "The Producer" to spread awareness about the various schemes of the producer.

- a. **Pamphlets & Brochures:** These will be detailed two-sided pamphlets/ brochures that will contain the following:
- a.1. Information of the buy-back scheme
 - a.2. Details of the DRF process
 - a.3. Process for end user for returning end-of-life Equipment
 - a.4. Website details and Toll-free helpline number
 - a.5. List of Collection Centers of the PRO
 - a.6. An info-graphic on the harmful effects of E-Waste on Environment if not handled in a safe and secure manner

These pamphlets/ information brochures will be provided to the user at the time of sale of products. As per estimated calculations for the producer, around 3000 pamphlets/ brochures will be printed for a given financial year. These pamphlets will be stapled with the Invoice at the time of new sale.

- b. **Publishing information on the website:** A central website (www.eprindia.com) of the PRO is available for all its associated Producers/ Importers of category ITEW7. This

website contains detailed information about the buyback schemes of the Producers associated with the PRO.

Additionally, the website also provides information about the nearest collection centers with their addresses and contact details. The website also contains information on the harmful effects of improper handling/ disposal of e-waste on the environment.

- c. **Toll Free Consumer Helpline & IVR Desk:** A central toll free helpline number (1800 121 9575) has been setup by the PRO. This toll free number, which would be operational five (5) days a week from 10 AM to 6 PM, will provide details of nearest collection centers and the buy-back schemes of linked Producers through an Interactive Voice (IVR) message to the user. Customer Support executives would be available to assist the callers with any further information
- d. **Banners/ flex boards at Retail stores and Distributor centers:** The printed advertisement material will be provided to all retailers/ dealers/ distributors (by the PRO) and they will be required to prominently display the same at their respective stores/ outlets.
- e. **Stickers to be pasted on all future products to be sold:** Permanent stickers with a prominent "Recycle symbol" and details of website and toll-free number of the PRO will be provided to the Producer by the PRO. ***The Producer will have to mandatorily paste/affix this sticker on new products being sold.***
- f. **Training to the Retailers/ Dealers/ Distribution for collection of the end-of-life Copying Equipment:** The retailers/ dealers/ distributors will be given training about the process of take-back – scrap value evaluation, collection and disposal of the end-of-life Copying Equipment, Multi-Function devices and their consumables. This will be a half day training delivered by the PRO training staff.

Consumer Awareness, Website Development and Toll Free helpline setup will be done by the PRO in a collective mode for all associated Producers of category ITEW7 products (Copying Equipment & Multi-function devices). Therefore, costs will be apportioned to all the linked producers of the said category by the PRO, and will be borne by all these producers.

Similarly, the PRO administrative and operational costs (including, but not limited to maintenance & operations of the website and toll-free helpline, collection center operations, channelization and reverse logistics of e-waste, will be apportioned to all the linked producers of the said category, ITEW7, of products, and will be borne by the producers, as determined by the PRO.
