**ORDER**

Whereas the Board notified the procedure for obtaining consent to establish and consent to operate and authorization under Water (Prevention & Control of pollution) Act, 1974, Air (Prevention & Control of pollution) Act, 1981 and Hazardous Waste (Management & Handling) rules, 2008 on 15.04.2014 covered under Red, Orange and Green category.

Whereas the CPCB vide office memorandum dated 02.06.2014 has issued following clarificatory amendment in the categorization of industries as Red, Orange and Green for grant of consent based on the recommendations of working group constituted in the 57<sup>th</sup> conference of Chairman & Member Secretaries held in August 2010:-

1. Under the list of red category of industries at Sr. No. 66 the entry "Power generation plants [except Wind, Solar and Mini Hydel of capacity <25 MW and DG set of >5 MVA capacity]" shall be replaced by "Power generation plants (excluding the following:
  - a. Wind & Solar renewable power plants of all capacity,
  - b. Mini Hydel power plants of less than 25 MW capacity,
  - c. DG set of capacity <5 MVA capacity)".
2. Under the list of Green category of industries at Sr. no. 79 the entry "Solar power generation through photovoltaic cell, wind power & mini hydel project (<25 MW)" shall be replaced by "Wind and Solar renewable power projects of all capacities, mini hydel projects plants of less than 25 MW capacity".

Whereas the matter was placed before the Board in its 172<sup>nd</sup> meeting held on 14.08.2014 vide resolution no. 172.7 and the Board approved the above said amendments. The minutes of the 172<sup>nd</sup> meeting of the Board were circulated vide letter no. HSPCB/Estt./2014/EG-36/2972-88 dated 25.08.2014.

Therefore in view of the decision of the Board, the entry at Sr. No. 1 above shall be replaced at Sr. No. 65 of Red category of industries in Annexure-A and Sr. No. 2 above shall be replaced at Sr. No. 73 of Green category of industries in Annexure-B in the policy notified on 15.04.2014.

The above said order shall be applicable with immediate effect.


