**Extended Producer Responsibility Plan of**  
**FORCEFOX TECHNOLOGIES PVT. LTD.**

FORCEFOX TECHNOLOGIES PVT. LTD. being the producer as per E-waste (Management) Rules, 2016 hereby submits detailed EPR plan. As a responsible corporate citizen FORCEFOX TECHNOLOGIES PVT. LTD. would always ensure strict adherence to compliance and follow all e-waste management regulations amended from time to time by government authorities. In-line with the requirement of new E-waste (Management) Rules, 2016 we propose to take several steps to implement the same as per guidelines issued by CPCB. We hereby submit our EPR plan detailing general scheme of collection, channelization plan, RoHS compliance details, etc.

**Brief on general scheme of collection**

3R Recycler is our service provider for collection, transportation, dismantling & recycling of E-waste. 3R Recycler having plant located at Plot No-266, Sector-8, IMT Manesar-122052 and its another entity 3R Recycler Pvt. Ltd. is having its plant at Plot-392, Sector-8, IMT Manesar-122052.

1. 3R Recycler would collect E-waste generated at FORCEFOX TECHNOLOGIES PVT. LTD. collection points across India and recycle it at their plant located in IMT, Manesar, Haryana.
2. 3R Recycler has confirmed to possess all mandatory authorisations from HSPCB related to e-waste management and has all consents related to Air/water/Hazardous waste. our recycler has two facilities of its own namely 3R Recycler and 3R Recycler Pvt. Ltd. They have a cumulative capacity of **11984 MT per annum**. (M/s 3R Recycler is having capacity of 1800 MTA per annum + M/s 3R Recycler Pvt. Ltd. 2994 MT per annum + M/s Khan Traders 7190 MT Per annum).
3. In view of projected sales volume and E-waste targets we have planned to follow below mentioned process for collection of e-waste.
4. As per our agreement with 3R recycler our customer can either handover their old product by contacting at 3R Recycler's Toll free numbers mentioned below.  
North India-**1800-102-8632**  
South India – **1800-843-3303**  
East India -**1800-843-3301**  
West India-**1800-843-3302** or they can drop it at our collection points.

3R Recycler representative would explain our customers about process of collection, channelization, dismantling, Recycling and make them aware about nearest drop point available to drop the e-waste and would also give them information about incentive that are being offered to them for handing over their end of life products. FORCEFOX TECHNOLOGIES PVT. LTD. would also offer e-waste pick up facility to our customers should they desire so and dismantle & Recycle the same at 3R Recycler's e-waste plant.

our service provider along with its reverse logistic partner can arrange pick up and transport of e-waste in a safe and environmentally sound manner and transport the same to its dismantling/recycling plant.

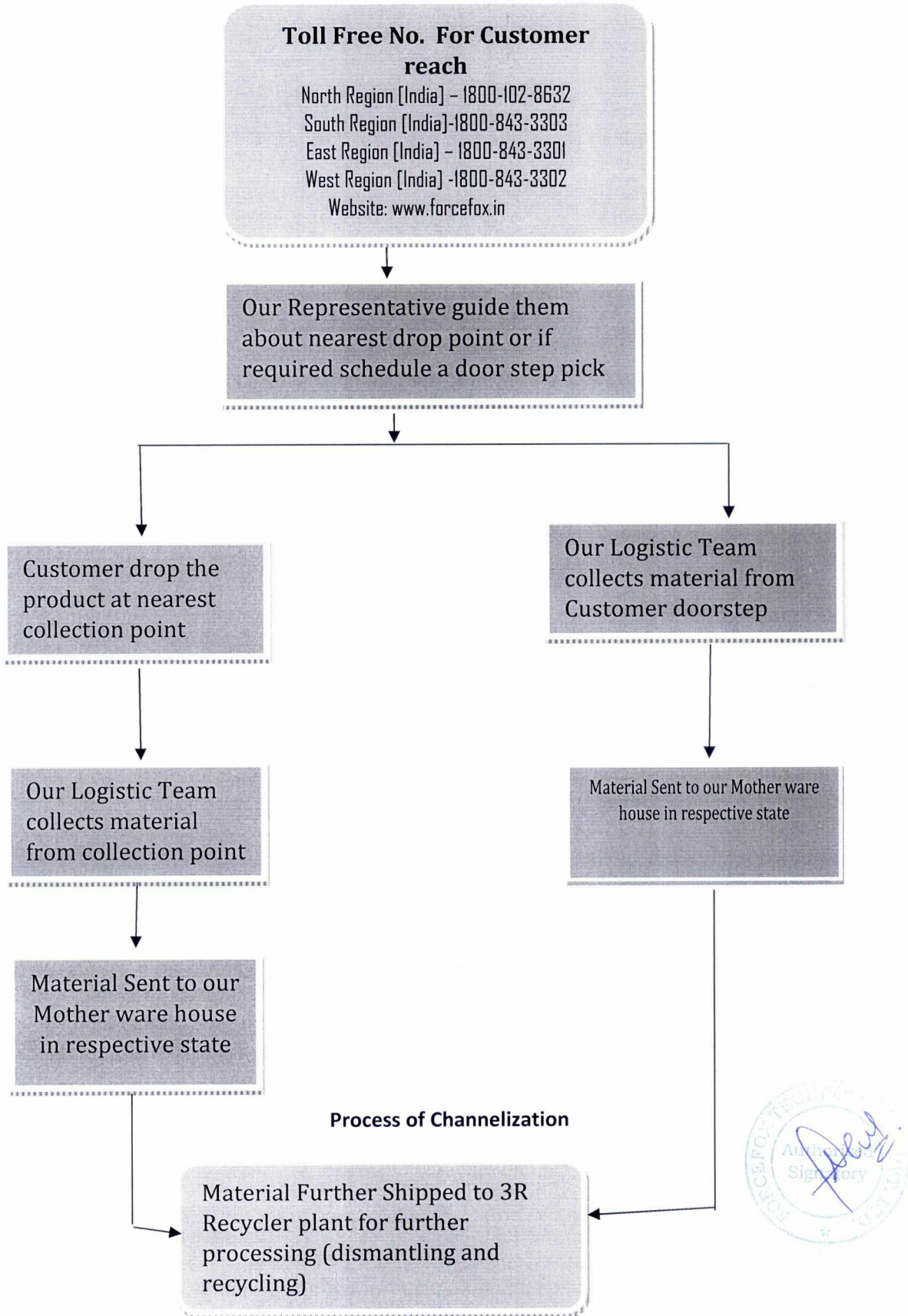
E-waste can also be picked up from consumer if he desires so. The collected e-waste will be transporter to our dismantler/recycler plant of its reverse logistics partner for dismantling and recycling.

The process to be followed by FORCEFOX TECHNOLOGIES PVT. LTD.for E-waste collection would be:

1. FORCEFOX TECHNOLOGIES PVT. LTD.would be contacted by end users through our service provider’s Toll free numbers:
  - North India-**1800-102-8632**
  - South India – **1800-843-3303**
  - East India -**1800-843-3301**
  - West India-**1800-843-3302**
2. FORCEFOX TECHNOLOGIES PVT. LTD./3R Recycler representatives would direct end users to the nearest e-waste collection centre/point or would arrange for a pick up facility.
3. Awareness among end users will be generated by including E-waste management information on our website, newspaper advertisements, user manual, product packaging and banners at FORCEFOX TECHNOLOGIES PVT. LTD.Service centres about hazardous or improper handling of E-waste as well as to enquire about nearest E-waste collection centre/point or to schedule a pickup from their door step with the help our pan India logistics partner.
4. FORCEFOX TECHNOLOGIES PVT. LTD.will install Collection Bins at allcollection points/Service Centres for collection of old Electronic products and their accessories, and for further channelizing to our e-waste management service provider.

**Whether all States are covered?**

Yes, FORCEFOX TECHNOLOGIES PVT. LTD. will cover all states in India for collection and channelization of E-waste from collection points. We have an agreement with 3R Recycler for collection, transportation of E-waste to its plant. [Copy of agreement with 3R Recycler and Forcefox as well as 3R Recycler and OM Logistics (service providers' logistics partner) is attached herewith]

**1. Specific collection schemes (buyback, exchange, DRS, etc.)**

FORCEFOX TECHNOLOGIES PVT. LTD. wants to encourage E-waste management by incentivising customers/end users who want to discard end of life product(s) (e-waste). Customers/end users are supposed to call toll free numbers:

- North India-**1800-102-8632**
- South India – **1800-843-3303**
- East India -**1800-843-3301**
- West India-**1800-843-3302**

to make an arrangement to collect the end of life product from their door step and depending upon life of product we incentivise our customer.

**a. Buyback**

We propose to incentivize customers/end users who wish to return their end of life product(s) (e-waste).

Customers/end users should call toll free numbers 1800-102-8632 (**North India**), 1800-843-3303 (**South India**), 1800-843-3301 (**East India**), 1800-843-3302 (**West India**), to know the process of recycling and the nearest Collection center/point to drop the E-waste. Customers/end user will also get information about any incentive or exchange offer that may be on offer, at that time, against their end of life product.

If any customer wants to handover the material at their doorstep we will arrange for either the logistics team or 3R recycler team to collect the item and channelize the same to our E-waste partner plant for final processing. We will incentivize our customer depending upon the remaining Life of the Product.

**b. E-waste Exchange:**

We propose to run an E-waste exchange program whereby we will encourage our customers/end users to deposit any of their old absolute products and their accessories (irrespective of brand). We propose to exchange the same with a promotional voucher or any other lucrative offers depending upon the remaining Life of the Product.

**c. DRS**

We have not opted for 'Deposit Refund scheme'.



2. **Agreements with Authorised Dismantler/ Recycler**

We have partnered with 3R Recycler for collection, channelization, dismantling, recycling of E-waste. They will collect the e-waste from our mother ware house, collection points and transport the same to its plant at IMT Manesar.

- 3. We propose to organise workshop in School, college retailers, dealer’s office to aware them regarding e-waste and its safe recycling.
- 4. We propose to advertise through pamphlets and booklets regarding safe handling and recycling of E-waste.
- 5. We will mention all the details related to management of e-waste/ toll free numbers/collection centres/points on our website to educate customers/end users on how to hand over end of life products to us.
- 6. We have established a Toll Free number for our customers if they want to give their End of life product for recycling they call on toll free number and handover the same to us, finally our E-waste management partner 3R Recycler collect those from across India branches and dispose the same in environmentally sound manner.
- 7. We shall encourage our customers/end users to deposit any of their old EEE products and their accessories (irrespective of brand).
- 8. We shall have collection centres/points for collection of e-waste material from customers/end users to channelize it through our e-waste management partner.
- 9. We shall print E- waste related information on job sheet, product and general publicity material.
- 10. We shall install E-waste Bin at our Collection centres/points across India and partner with 3R Recycler for its collection and recycling.
- 11. We propose to regularly conduct awareness drive at all our offices and provide proper training to employees about handing of E-waste.
- 12. Affixing a visible, legible and indelible symbol (non-disposal as ordinary waste) on the products or information booklets to prevent e-waste from being dropped in garbage bins containing waste destined for recycling.
- 13. We will create awareness about e-waste management by mentioning it on our website, product publicity posters, and information booklets accompanying the equipment with regard to:
  - a) information on hazardous constituents (like lead, mercury, cadmium or chromium) in electrical and electronic equipment;
  - b) information on hazards of improper handling, accidental breakage, damage and/or improper recycling of e-waste;
  - c) instructions for handling of the equipment after its use along with the Do’s and Don’ts; and
  - d) Affixing a visible, legible and indelible symbol (non-disposal as ordinary waste) on the products or information booklets to prevent e-waste from being dropped in garbage bins containing waste destined for recycling.

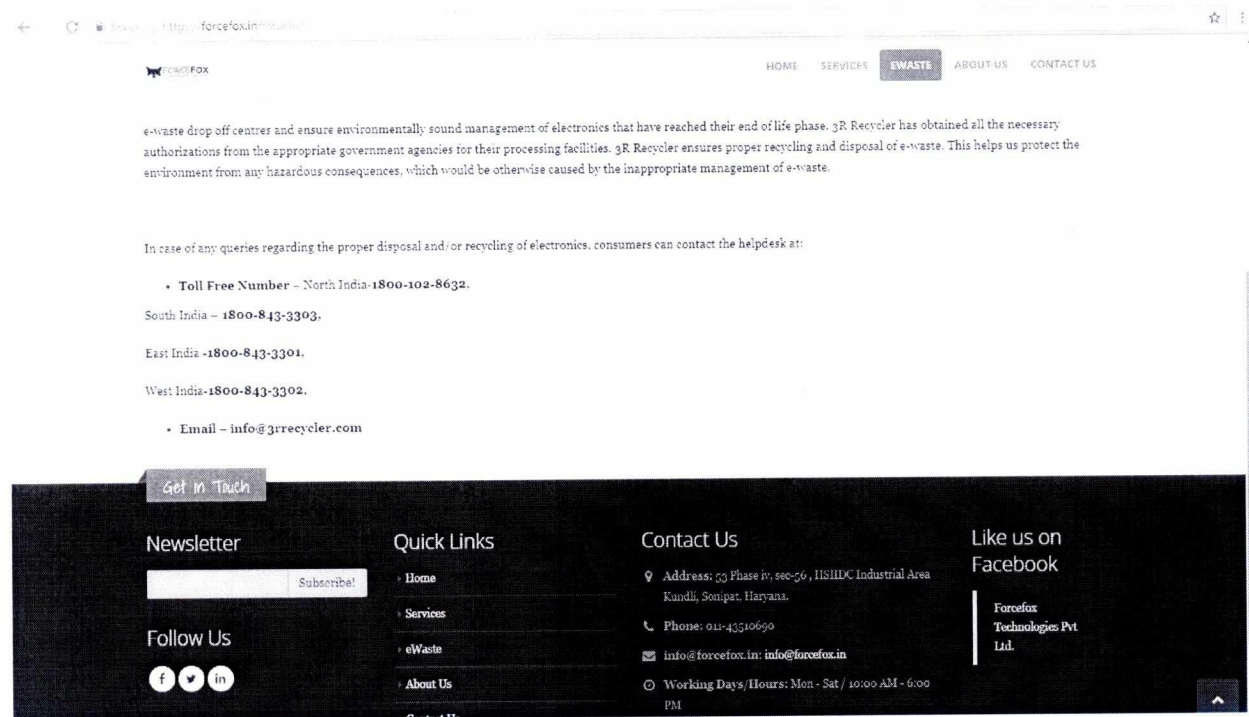
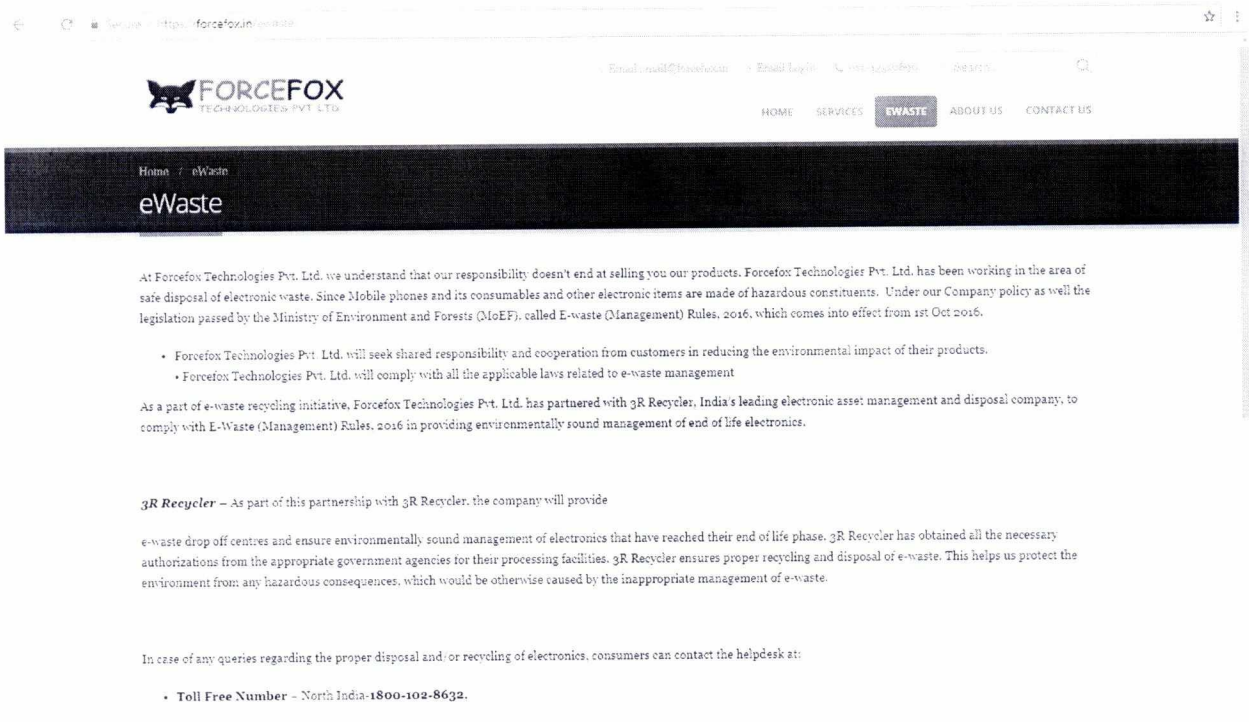
