### Office Order

Whereas, the Principal Secretary to Govt. of Haryana, Industries & Commerce Department-cum-Chief Executive Officer, Haryana Enterprises Promotion Centre (HEPC) has asked vide his Memo No. HEPC/Meeting-HEPC/2017/370 dated 31.07.2017 that the service of consent to operate under Air Act, 1981 and Water Act, 1974 for new investors/enterprises may also be routed through HEPC Portal (<https://investharyana.in>) on the lines of consent to establish (CTE), to ensure to enhance the ease of doing business in the state;

Whereas, no application for CTE is being received presently through the portal of the Haryana State Pollution Control Board (HSPCB) and all the applications for CTE are being submitted by the investors only through the portal of HEPC;

Whereas, the above proposal of the Principal Secretary to Govt. of Haryana, Industries & Commerce Department-cum-Chief Executive Officer, HEPC has been considered and it has been decided to stop the receiving of the applications for grant of first Consent to Operate (CTO) under Water Act, 1974 and Air Act, 1981 with immediate effect on the portal of this Board, from new investors/units.

In view of above and to ensure to enhance the ease of doing business in the State, it is hereby ordered that all the new investors/units who have already obtained CTE from the Board and willing to obtain first CTO for commissioning the production/activity in their project, shall apply for the same only through HEPC Portal (<https://investharyana.in>), on the lines of procedure adopted for obtaining consent to establish (CTE) and no such application will be received directly on the portal of HSPCB in future.

These orders shall come in to force with immediate effect.
