Office Order

Whereas the inspection policy of the Board was circulated vide Head Office order Endst. No. HSPCB/PLG-142/2016/5371-95 dated 24.02.2016, wherein it has been provided in clause 3 that inspection of the industries will be carried out by the officer/officers of the Board with prior approval by the competent authority of the Board;

Whereas, authorities has been prescribed vide order endst. No. HSPCB/PLG/142/2016/6493-6518 dated 20.04.2016 and subsequently vide this office order endst. No. HPCB/PLG/142/2016 398-421 dated 05.07.2016 for according permission for conducting various inspection of the units by the officers, defined in

the inspection policy of the Board;

Whereas in the Regional Officer's meeting held on 25.05:2018 it was decided that the powers be delegated to Regional Officers to grant the permission for inspection of industries in case of checking of the status regarding installation of pollution control measures/devices and compliance of conditions of CTE at the time of grant of 1st CTO and for collection of paid samples of effluent/air emissions/noise as the case may be, against the payment made by such units, after grant of 1st CTO subject to compliance of the provisions of inspection policy of the Board and minutes of the same were circulated vide letter no. HSPCB/PLG/2018/4394-4422 dated 06.06.2018;

Whereas as per clause no. 4.2.5 of the inspection policy, inspection of only those units against which complaints will be received only through CM Window portal, District Level Grievance Committees and otherwise by Deputy Commissioners, will be done by the authorized officers of the Board with due permission of competent authority, whereas due to this clause of the inspection policy the complaints which are received through MoEF&CC and CPCB, are not being considered for inspection and verification;

Whereas the matter has been examined and it has been decided that complaints received through MoEF&CC and CPCB may also be considered for the inspection to verify the facts of the same and this mode of receipt of complaints may be incorporated in the clause 4.2.5 of the inspection policy of the Board;

Whereas the Board vide agenda item no. 180.13 in its 180th meeting held on 08.06.2018, approved the proposal for delegation of powers to the Regional Officers of the Board for grant of permission to the field officer of their respective regions for inspection of industries in case of checking of the status regarding installation of pollution control measures/devices and compliance of conditions of CTE at the time of grant of 1st CTO and for collection of paid samples of effluent/air emissions/noise, as the case may be, against the payment made by the units, after grant of 1st CTO in partial modification of the order issued by the Board vide endst. no. HSPCB / PLG-142 / 2016 / 6493-6518 dated 20.04.2016 and subsequently vide this office order endst. No. HPCB/PLG/142/2016 398-421 dated 05.07.2016 regarding prescribing the authorities for grant of permission for inspection and sampling of units. It has also been approved by the Board vide agenda item no. 180.13 in its 180th meeting held on 08.06.2018, to include the mode of receipt of complaint from MoEF&CC and CPCB in Clause No. 4.2.5 of Inspection Policy for grant of permission for inspection for verification of such complaints.

In view of above and in partial modification in Clause No. 4.2.5 of Inspection Policy and in order issued vide this office Endst. No. endst. no. HSPCB / PLG-142 / 2016 / 6493-6518 dated 20.04.2016 and subsequently vide this office order endst. No. HPCB/PLG/142/2016 398-421 dated 05.07,2016, it is hereby ordered that:-

- All Regional Officers are authorized to grant the permission to the field officers of their region for inspection of industries in case of checking of the status regarding installation of pollution control measures/devices and compliance of conditions of CTE at the time of grant of 1st CTO and for collection of paid samples of effluent/air missions/noise as the case may be, against the payment made by the units, after grant of 1st CTO subject to compliance of the inspection policy
- The complaint received through MoEF&CC and CPCB will also be considered by the Competent Authority for grant of permission of such industries to verify the facts of the same and this mode of receipt of complaint is also included in the clause 4.2.5 of the inspection policy of the Board apart from other such mode of receipt of complaints prescribed in this clause of inspection policy.

This order shall come into force with immediate effect.
