**Proceedings of the Meeting held under the Chairpersonship of Smt. Keshni Anand Arora, IAS, Chief Secretary, Haryana at 1200 Hrs on 01.09.2020 regarding issues to be discussed in OA No. 6/2012 (Manoj Mishra Vs UOI & Ors) on 04.09.2020.**

A Preparatory Meeting was held under the Chairpersonship of Smt. Keshni Anand Arora, IAS, Chief Secretary, Haryana at 1200 Hrs on 01.09.2020 at Main Committee Room, Haryana Civil Secretariat, Chandigarh regarding the issues to be discussed in the Video Conference Meeting of NGT in OA No. 6/2012 (in the matter of Manoj Mishra Vs UOI & Ors) scheduled on 04.09.2020. The list of participants is enclosed at **Annex**.

Chairperson after welcoming all the participants, briefly informed about the objectives of the meeting.

Member Secretary, HSPCB explained the background of the communication that RYMC had sent to NGT seeking clarification on their role in use of different funds like Environment Compensation (EC) collected from violators, consent fees collected from the industries and the Corporate Social Responsibility (CSR) funds earmarked by industries for different purposes. CS reviewed the status of funds available with different agencies like HSPCB (Consent Fees collected and EC collected for violations), Agriculture Department (EC collected against crop residue burning) and CSR funds available with Industries Department.

PHED and ULBD informed that they have sufficient funds for implementing their action plans and facilities.

After deliberations, Chief Secretary directed that a note be prepared by HSPCB on the updated status of these funds available with HSPCB, Industries and Agriculture Departments, after collecting the details from them.

Principal Secretary, Panchayat Department was advised to prepare a plan with details of possible treatment facilities and requisite funds as well as the possible sources for the same.

CS also directed ACS Environment to put up the details of available funds under EC and consent funds alongwith the expenditure incurred thereon till date. Besides audited financial statement with ITR of HSPCB of last three years be also put up on file within a week.

Meeting ended with thanks to all the participants.
