



**Proceeding of the meeting held at 1600 Hrs on 29.08.2019 under the Chairmanship of Smt. Keshni Anand Arora, IAS, Chief Secretary, Haryana in Main Committee Room, Haryana Civil Secretariat, Chandigarh regarding finalization of action plan for reuse/utilization of the treated waste water.**

A meeting was held at 1600 Hrs on 29.08.2019 under the Chairmanship of Smt. Keshni Anand Arora, IAS, Chief Secretary (CS), Haryana Main Committee Room, Haryana Civil Secretariat, Chandigarh, with senior Officers of all stakeholder Departments, to discuss and resolve issues regarding finalization of action plan for reuse/utilization of the treated waste water dealt in the matter of OA No. 148 of 2016 Mahesh Chander Saxena. The list of participants is enclosed at Annex.

Chief Secretary welcomed all the participants and explained the objective of the meeting. Member Secretary, HSPCB informed that Hon'ble NGT, while dealing the case of OA No. 148/2016 (Mahesh Chander Saxena Vs State of Haryana and Others), directed the States to submit an action plan on reuse of treated waste water to CPCB as per Guidelines of CPCB. Though this direction was issued in November 2018, the State, through PHED, submitted it only a few days back. The matter was heard on 27.08.2019 by the Tribunal but the orders have been reserved.

The officers of PHED opined that the Irrigation Department be designated as Nodal Department for finalizing the action plan for reuse of treated waste water on behalf of State of Haryana. EIC, Irrigation Department apprised that they shall assist in preparing action plan but the nodal Department should be PHED only. After a brief discussion on the subject, it was decided that PHED should be the Nodal Department in the matter and will revisit the plan submitted and get it modified according to the guidelines of CPCB, incorporating inputs from all concerned Departments/Agencies and giving a specific timeline for every activity, as directed by NGT.

The meeting ended with thanks to all participants.
