Proceedings of First Fortnightly review meeting held on 05.2.2020 regarding of the status of Yamuna and Ghaggar Action Plan in OA No. 673 of 2018 "More river Stretches are now critically Polluted: CPCB"

A meeting under Chairmanship of Smt. Keshni Anand Arora, IAS, Chief Secretary, Haryana was held on 05.02.2020 at CS Committee Room, Haryana Civil Secretariat in Chandigarh to review the progress on Yamuna and Ghaggar Action Plan in matter of in OA No. 673 of 2018 "More river Stretches are now critically Polluted: CPCB". The list of participants is enclosed at **Annex**.

The Chief Secretary asked the Chairman, HSPCB to brief about the issues mentioned in the DO letter dated 22.01.2020 written by the Secretary, Jal Shakti, Govt., of India, New Delhi. The Chairman, HSPCB briefed that the Hon'ble NGT has passed order dated 06.12.2019 and directed that quarterly report be submitted by Secretary, Jal Shakti to NGT. The Secretary, Jal Shakti has to monitor the progress of all states on monthly basis with the help of NMCG and CPCB. Therefore, the monthly status has to be submitted to NMCG. The State has been mandated to monitor on fortnightly basis. The Nodal Officers for each department not below Secretary Level are to be designated for monitoring purpose and to ensure adverse entries in ACRs of erring officers. The Chief Secretary has been directed to attach an accountable officer in her office accordingly and she designated MS, HSPCB for fortnightly monitoring at State Level for this purpose.

Hon'ble NGT has also directed that DPR/ tender process need to be shortened and the concerned departments were advised to look into and take appropriate steps. The Performance Guarantee should be taken for contractors executing various activities/ projects of the Action Plan. The officers of PHED informed that they have been taking Performance Guarantee from the contractors who are assigned contracts for STPs / Sewerage Networks.

Sh. JP Singh SEE, HSPCB informed that as per NGT orders dated 20.09.2018 the state has to submit plan for ground water Management and its regulations. Accordingly, as a first step, Ground Water Regulation Act was to be got enacted by Agriculture Department but the same is pending and no report received so far. The CS desired that a DO letter to ACS Agriculture be got written through CS, Haryana.

Chairman, HSPCB informed that some towns have been transferred from PHED to ULBD. The laying of sewerage network and other works covered under AMRUT projects have only been under taken by the ULBD. There are other areas in AMRUT towns which have uncovered approved colonies as well as unapproved colonies from where sewage is generated and flow is required to be intercepted, collected and treated. Similarly, in other towns also it has to be ensured that all the flow from approved and unapproved colonies is collected through sewerage system or interception sewers and treated. It has to be ensured that no sewage is disposed off without treatment into the drains. These areas are still unaddressed and departments have to undertake work for these areas. CS directed that ACS, PHED and ACS, ULBD to jointly resolve the issues involved.

CS informed all the participants that RYMC has already submitted its report to Hon'ble NGT in matter of OA No. 6/ 2012-Manoj Mishra Vs UOI. In the meeting held on 10.01.2020 at Haryana Bhawan, New Delhi, the RYMC had shown concern about untreated effluent of Yamuna Nagar / Jagadhari Town. They were also concerned about slow progress of laying of sewerage in Panipat and Sonapat Towns. After brief discussion on the issues of RYMC, the CS directed that the work/ projects of Panipat town be given priority and all concerned activities be expedited.

Regarding the status of industrial discharge from Yamuna Nagar, ACS, Industries may hold a meeting with MD, HSIIDC on this issue to expedite setting up of CETP at Yamuna Nagar.

CS desired that ACS, Environment to review the progress for the actions desired by RYMC in matter of OA No. 6/ 2012 with concerned department.

Meeting ended with thanks to all participants.
