- d. That the applicant has to submit to CPCB every quarter the amount of (in number or weight) of e-waste of EEE Code –ITEW15 collected in that quarter and recycled;
- e. That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- f. In case of any violation of the above condition, your authorization will be suspended/cancelled;
