Notification

The 6th April, 1998

No. S.O.36/C.A.14/1981/S.54/98.—In exercise of the powers conferred by Section 54 of the Air (Prevention and Control of Pollution) Act, 1981 (Parliament Act 14 of 1981), the Governor of Haryana after consulting the Haryana State Board for the Prevention and Control of Water Pollution hereby makes the following rules further to amend the Haryana Air (Prevention and Control of Pollution) Rules, 1983, namely :—

1. (1) These rules may be called the Haryana Air (Prevention and Control of Pollution) First Amendment Rules, 1998.

(2) These rules shall be deemed to have come into force with effect from 5th December, 1997.

2. In the Haryana Air (Prevention and Control of Pollution) Rules, 1983, in rule 13, in sub-rule (2), in the table, under columns 1 and 2,—

(A) entries under heading AIV, the following entries shall be substituted, namely :—

“(A)-IV(i) CONSENT FEE TO ESTABLISH (NOC) STONE CRUSHERS

(a) Crushing Unit with the capacity not exceeding 100 tons/day .. 5,000

(b) Crushing Unit with the capacity not exceeding 100 tons/day .. 7,500

(ii) CONSENT FEE TO BE CHARGED ANNUALLY TO OPERATE STONES CRUSHERS

(a) Crushing Unit with the capacity not exceeding 100 tons/day .. 5,000

(b) Crushing Unit with the capacity exceeding 100 tons/day .. 7,500

(iii) FEE FOR TRANSFER OF CONSENT TO OPERATE STONE CRUSHERS

(a) Crushing unit with the capacity not exceeding 100 tons/day .. 20,000

(b) Crushing Unit with the capacity exceeding 100 tons/day .. 35,000.”
