Sub : Weeding out of the old record of HSPCB.

A letters along with list of files were issued vide No. I/161055/2023 dated 26.04.2023 and vide No. I/163812/2023 dated 05/05/2023 to Archives Department for grant of NOC to weed out old record. The Board has decided to weed out:-

1. 194 individual files of retired employees who have been given pension one year back and not avoided any medal from Govt.
2. 683 RTI files which were closed 3 years back.
3. 1258 files of industries which are not existing on ground and were dismantled.

The Director, Archives Department was requested to depute the officer of their department for inspection of the concerned files in our head office and grant the NOC to weed out the same. The corresponding files of the Regional Offices shall be weeded out simultaneously.

The Archivists of the Department visited HSPCB, Head Office on 22/03/2023 for inspection of the record and after inspection, the Director, Archives Department, Haryana, Panchkula has issued the NOC to weed out 2135 files vide letter dated 29/03/2023.

In view of above, the approval is hereby accorded to weed out the (194+683+1258= 2135) files of Head Office (**List enclosed**) as well as corresponding files of Regional Offices for which NOC has been given by the Archives Department, Government of Haryana, Panchkula.
