Office Order

Whereas, the Board vide Head Office order Endst. No. HSPCB/2020/PLG/1767-1795 dated 04.12.2020 has amended its existing consent procedure issued vide Head Office order Endst. No. HSPCB/2018/517-546 dated 26.02.2018 for grant of consent to establish and consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981, along with consolidated list of industrial / non-industrial sector /projects covered under Red, Orange, Green and White Categories. This procedure had been issued based upon the directions issued by the CPCB u/s 18(1)(b) of Water Act, 1974 and Air Act, 1981 vide letter no.B29012/ESS (CPA)/2015-16/8526 dated 07.03.2016 and subsequent directions thereon; and

Whereas, Hon'ble NGT in the matter of OA No. 400/2017 titled as Westend Green Farms Society Vs Union of India &Ors and n OA No. 26/2019 titled as Abhay Singh Dahiya Vs State of Haryana has directed all States/UTs to take further steps for enforcing CPCB guidelines and mechanism for Control of Pollution and Enforcement of Environment Norms at Individual Establishments and the Area/Cluster of Restaurants/Hotels/Banquets;

Whereas, to comply with the directions of Honble NGT, it had been ordered vide order Endst. No. HSPCB/PLG/2021/2210-22264 dated 13.09.2021 (Annexure-IV) to add Restaurants / Dhabas / Motels / Marriage Halls / Banquet Halls / Party Lawns in the list of industrial / non industrial sector /projects of Red, Orange and Green Categories, already issued vide Head Office order Endst. No. HSPCB/2020/PLG/1767-1795 dated 04.12.2020;

Whereas, Regional Officer, Ambala sought clarification regarding floor area when dealing with cases of small restaurant and dhabas with seating capacity less than 36 and discharge is less than 10 KLD;

Whereas, the matter was placed before the Technical Advisory Committee (TAC) of the Board in its meeting held on 11.09.2024. The proceedings of the TAC were circulated vide letter no. 3520-28 dated 10.10.2024 and it has been recommended by the TAC that following category may be replaced with the category mentioned at Sr. no. 3 in policy order dated 13.09.2021;
