Sub:- Proceedings of the VC held 02.01.2025 at 12:00 Noon under the Chairmanship of Sh. Vineet Garg, IAS, Chairman, HSPCB with SESTFs/ DSTFs in his office room at 4<sup>th</sup> Floor, Mini Secretariat, Sector-17-D, Chandigarh.

The meeting was held on 02.01.2025 at 12:00 Noon under the Chairmanship of Sh. Vineet Garg, IAS, Chairman, HSPCB with SESTFs/ DSTFs in his office room at 4<sup>th</sup> Floor, Mini Secretariat, Sector-17-D, Chandigarh to review the implementation of the Yamuna Action Plan. The list of participants is enclosed as **Annexure**.

Right at the outset, the Chairman welcomed all the participants and requested Sh. JP Singh, SEE to brief about the agenda. It was discussed that the matter concerning air pollution in the case of WP NO. 13029/1985 - MC Mehta Vs UOI is pending before Hon'ble Supreme Court. It was also conveyed that the Hon'ble Court has taken the matter very seriously and giving very short dates. It was apprehended that similar issue may arise in case of water pollution also, as lot of froth formation in river Yamuna is being reported in the media. The experts suggest various reasons for froth formation, such as presence of phosphates & ammonia in the effluents. The possible sources can be textile washing and dying units. The Board has received lot of complaints on NMCG Portal and X account. The action plan already submitted mostly deals with domestic sewage but visible action for industrial pollution also needs to be given. It was further mentioned that the HSPCB has already started an X Account (Twitter) in compliance of Hon'ble Supreme Court directions. All officers should open their account on X and follow the Haryana SPCB. Public complaints are tagged to the HSPCB account by the CPCB/ CAQM, which are to be responded by the HSPCB mandatorily.

Hon'ble NGT vide dated 15.09.2018, has constituted RRC and SESTF and mandated them to prepare action plan and implement thereof. The person doing good work need to be rewarded. Further, Hon'ble NGT has multiple times observed the failures of administration/regulators and directed that these failures be entered in ACRs of the concerned defaulting officers.

During the previous meeting, it was directed that the ATR for last week in case of water pollution / YAP and action to be taken for coming week be explained. After detailed discussion, the following decisions were taken:-

- 1. As the action taken during last week was not sufficient, the ROs need to activate SESTF and take comprehensive action against violators and also those who shield or facilitate them. The landowner details must be collected to persuade them not to allow any illegal activity.
- 2. All ROs should report daily to the Water Cell of the action taken against illegal disposal of effluent through tankers or illegal industries, on the following format:-

Subsequently, the action taken reports of individual districts were reviewed and brief proceedings are given in coming paras.

RO Karnal did not provide detail of illegal industry/ tankers penalized for last 3 months and averred that there are no such industry/tankers in Karnal Region.

RO Ballabgarh claimed that they have taken action but have not sent the ATR for proceeding. They were countered that the ATR was to be sent on daily basis to water cell. Further, as the actions of SESTFs have no effect on ground sofar and accordingly, this need to be monitored closely at HQ level.

AEE, NUH informed that they have been in process to obtain the names of violating persons/ land owners in one such case for past 1 year but couldn't get it from the concerned department. They were advised to send the names of officers of the department whom they have asked to send the names of violating person/ land owners along copy of communications made in this regard so that the matter could be reported to the Chief Secretary, Haryana.

RO Panchkula informed that they have closed the illegal RMC Plant near Amravati Enclave and resealed it, as it was running after breaking the seal. He was advised to immediately restrain the unit through court under the provisions of Water/Air Act if the unit again break the seal and continue its operation.

RO Sonepat has taken action against illegal industries. But he didn't find any tanker for illegal disposal of effluent. RO Sonepat was advised to take action as per the recommendations in the report submitted by committee of Dr. Babu Ram, Technical Expert and Sh. J.P. Singh, SEE in case M/s AB nBeV, Sonepat. The unit has to make additional safeguards for environment management as per recommendations of the committee.

RO Kaithal has taken action but could not send the ATR for proceedings of the previous meeting. They were advised to send the ATR immediately after the meeting, so that it can be analysed for submission before the competent authority.

RO Ballabgarh, Palwal, Gurugram North, Gurugram South have not sent any ATR for previous meeting. They were advised not to repeat the lapses.

After reviewing all the ATRs, the Chairman requested all the members of SESTFs to work in a mission mode as per mandate given to them by Hon'ble NGT and directed that the meeting at the level of Chief Secretary, Haryana be held with SESTF and it was decided that

- 1. The names of SESTF members who did not attend this meeting even after being informed be given within 3 days.
- 2. The action be taken against illegal tankers disposing polluted effluent at places other than STPs.
- 3. The decisions of previous meeting be complied with.
- 4. The action plan to control the industrial pollution be added in action plan for drains or certificate be given that there is no industrial pollution from the respective area of jurisdiction.
- 5. The review meeting be held every first Thursday of the month.

Meeting ended with a vote of thanks to the chair and also the participants.
