Sub:- Proceedings of the meeting held 11.09.2024 at 11:00 AM under the Chairmanship of Sh. P. Raghavendra Rao, Chairman, HSPCB with SESTFs.

The meeting was held 11.09.2024 at 11:00 AM under the Chairmanship of Sh. P. Raghavendra Rao, Chairman, HSPCB with SESTFs. The list of participants is enclosed as **Annexure-1**.

Right at the outset, the Chairman welcomed all participants. He exhorted members of SESTF to work in a mission mode towards cleaning of rivers vide order dated 15.09.2018, Hon'ble NGT has given the mandate to SESTFs to prepare action plan for cleaning of rivers. They should identify sources of pollution and also initiate civilian/ criminal proceeding against violators well as those who shield them. Simultaneously, the good activities should be rewarded also. This meeting is being held after a longtime but such meetings should be held on regular basis at level of RRC. Further, a lot of complaints for industrial pollution are being received on Grievance Redressal portal of NMCG which was launched as per NGT directions. In matter of OA No. 673/ 2018 "More River Stretches are critically polluted now". These complaints should spontaneously and immediately be addressed and action should be taken.

Thereafter, the Chairman requested Sh. JP Singh, SEE, HSPCB to take up the agenda one by one. The agenda points were discussed and after the discussions the proceedings are given in coming paras given as under:-

1. Complaints on NMCG Portal

It was briefed that NMCG Govt. of India marked the public grievance complaints to Chief Secretary, Haryana for redressal. The complaints were sent to concerned ROs for action through SESTFs. Most of time the name/ address of violators are not available and accordingly, the action for prosecution/ Environment Compensation is not taken. The violators continue their operation at some other place or same place. In this regard, it was suggested that the name of land owners to be taken as they allow illegal activity on their lands. The officers of Revenue Department and Electricity Department should also be invited for expeditious action. In case, they do not respond positively then matter be reported immediately to DC under intimation to the RRC. The violators should be identified at all cost. Most of the ROs informed that they have sent the ATR for complaints. It was conveyed that, many times, ROs send partial ATR i.e. SCN issued. It was clarified that complete action be taken and then send for disposal of complaints.

2. Offline OMDs of STPs / Industries

The STPs/ Industries are not displaying data. There are around 300 units offline every day. The violators have to be penalised. The SESTFs were advised to

check the no. of offline units on website of the Board and action be taken against offline units.

3. Action Plan for drains

Ministry of Jal Shakti, GOI has pointed out that Haryana State has put most of the infrastructure/ hardware for treatment of effluents but still the situation of drains have not improved. Some of the drains even gone worst with progress of Action Plan. The improvement is not upto desired level for last 6 years inspite of making huge expenditure.

Recently, there was news item for FIR against PSPCB and even the Hon'ble NGT had ordered for prosecution of Chairman/ MSPCB of Chattisgarh State. That is a totally undesirable situation and mostly due to non-performance of field functionaries. It was conveyed that drain wise action plan for all polluting sources has been submitted but it, nowhere address the pollution due to industries though the complaints on NMCG portal are almost about industrial pollution. RO Sonapat informed that action is being taken in case of HSIIDC Industrial area at Barhi, Sonapat. He was advised to look into matter of industrial effluent discharge into storm water drain of the industrial area. It should also be enquired how come a industry succeeds in making a effluent discharge connection into storm water drain. The responsible officer of HSIIDC for storm water drain should be taken action against.

On similar pattern, the drainwise action plan be prepared for river Ghaggar also. It has been sought numerous times in the past.

4. Visit by DC/ ADC

There is no visit by Senior Officers to the site of under construction projects i.e. STPs/ CETPs/ sewerage etc. The most of the project did not get completed in time and timelines keep on extending. The Chairman emphasised that such visits shall make a lot of difference in removing bottle necks and to meet with the targeted timelines for completion of the project.

Meeting ended with vote of thanks to the chair and also the participants.
