It is for the information of all concerned that M/s Ambuja Cement Ltd has proposed project "Naultha Cement grinding unit with cement production capacity of 1x4.0 Million MTPA at Village Naultha Tehsil Israna, District Panipat, Haryana ". The project is covered under the ambit of Environment Impact Assessment Notification No. S.O. 1533 (E) dated 14th Sep, 2006 issued by Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi and thus Environmental Clearance is mandatory for the proposed project.
