

This is for the information of all the Industries/project proponents that Industrial units/projects falling under Red, Orange and Green Categories of consent management of the Board as per order of categorization issued vide Endst. No. HSPCB/PLG/PLG-135/2016/546-572 dated 14.07.2016 and subsequent order Endst. No. HSPCB/2018/517-546 dated 26.02.2018 (as amended), are required to apply to this Board for obtaining consent to establish (CTE) and consent to operate (CTO) under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and for authorizations/registrations under various Waste Management Rules under Environment (Protection) Rules, 1986 through online portal of Haryana Enterprises Promotion Centre (HEPC).

The Central Pollution Control Board (CPCB) has issued directions under section 18 (1)(b) of the Water (Prevention and Control of Pollution) Act 1974 vide letter no. B-29016/ROGW/IPC-VI/2020-21/ dated 30.04.2020 regarding categorization of some new industrial sectors i.e. railway stations, scrapping centres, Compressed/refined bio-gas production for bio-degradable wastes and other industrial sectors and listing of Non-Industrial Operations (Activities/ Facilities/ Infrastructure/ Services) and subsequent letter no. B-29016/ROGW/IPC-VI/2020-21/ dated 10.07.2020 regarding categorization of Dairy Farm and Gaushala.
