Extended Producer Responsibility Plans

Brief on general scheme of collection

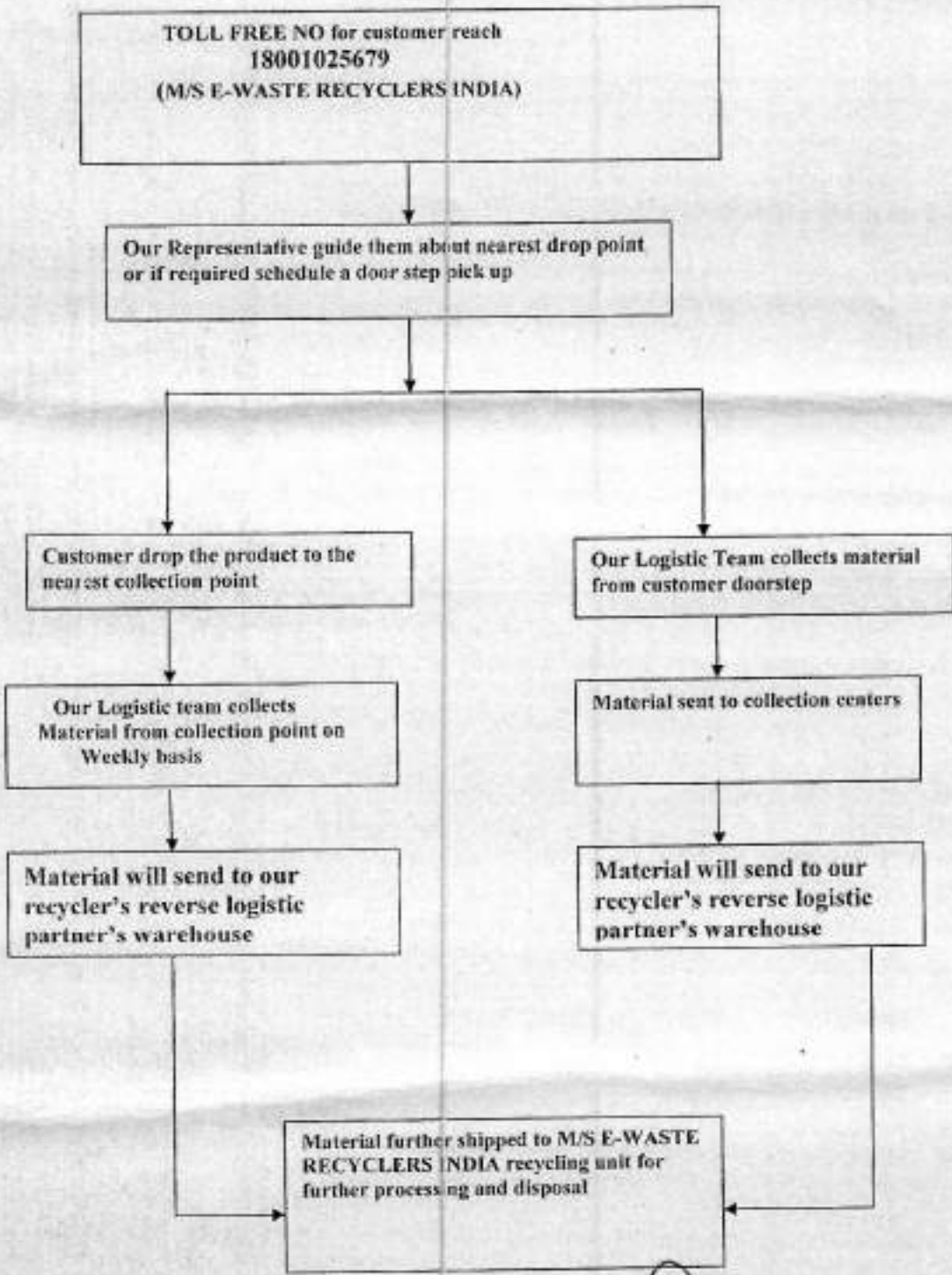
