State Level Advisory Committee Constituted Under Bio Medical Waste Management Rules, 2016

ORDER

Whereas, the State Level Advisory Committee (SLAC) for the State of Haryana constituted under the Bio Medical Waste Management Rules, 2016, considered the representation of M/s Surya Waste Management, Sirsa and based on the recommendations of the Sub-Committee constituted by SLAC on 07.03.2019, the Member Secretary of Haryana State Pollution Control Board (HSPCB) cum Member Secretary of SLAC, issued an order on 10.08.2020 re distributing the areas among Common Bio Medical Waste Treatment Facilities (CBWTFs) of M/s Invision Enviro Services, Sirsa, M/s Synergy Waste Management Ltd., Hisar and M/s Surya Waste Management, Sirsa;

Whereas, M/s Synergy Waste Management Private Ltd., aggrieved by the above order, approached the Hon'ble High Court of Punjab and Haryana and the Hon'ble High Court through a CWP 13795/2020, vide its order dated 01.10.2020, set aside the above indicated order and directed that the Additional Chief Secretary of Health and Family Welfare Department, Government of Haryana shall hear the petitioner before passing any order and a fresh order be passed accordingly; and,

Whereas, Additional Chief Secretary, Health and Family Welfare Department cum Chairman, SLAC, heard the petitioner in compliance of the directions of Hon'ble High Court of Punjab and Haryana at 1130 Hrs on 14.10.2020 and accordingly a committee was constituted vide order no. HSPCB/2020/13060-80 dated 27.10.2020, under the Chairmanship of MD, NHM with Members from DGHS, HSPCB and IMA with the mandate to examine the matter of representation of the CBWTFs and a detailed report was directed to be submitted to ACS (Health) cum Chairman SLAC, within a period of one month.

Whereas, the said sub-committee reviewed the representation of CBWTFs in its meeting held on 02.11.2020 and submitted its recommendations/report for consideration before the SLAC.

Whereas the 6th SLAC meeting was held on 19.01.2021 at 12.00 Noon under the Chairmanship of Additional Chief Secretary to Govt. of Haryana, Health Department and the agenda point no. 2 regarding decision on the recommendation of the committee constituted by SLAC under the Chairmanship of MD, NHM regarding representation of area distribution among CBWTFs was discussed and the same is approved.

Therefore, the distribution of area among Common Bio medical Waste Treatment Facilities (CBWTFs) mentioned below be considered with immediate effect:-

Further the area of the rest of the nine CBWTFs is not changed. Area distribution of among all remaining CBWTF will remain the same as before the redistribution order dated 10.08.2020.
