Guidelines for Handling, Treatment, and Disposal of Waste Generated during Treatment/Diagnosis/Quarantine of COVID-19 Patients-Revision 2-reg.

Whereas, guidelines for management of waste generated during diagnostics and treatment of COVID-19 suspected/confirmed patients on 18th March 2020 by the Central Pollution Control Board which are to be followed by every hospital, isolation centers, laboratories and common bio-medical waste treatment and disposal facilities. Copy of the same was circulated by Haryana State Pollution Control Board to all the Stockholders/concerned Vide letter No.HSPCB/HQ/SWM/2020/1243-84 dated 23/3/2020. Thereafter, in order to proper treatment and safe disposal of bio-medical waste generated during diagnostics and treatment of COVID-19 suspected/confirmed patients, Central Pollution Control Board is updating and framing revised guidelines from time to time. So far four revisions have been issued, out of which 1st & 2nd have already been sent to you for information and proper implementation on ground level. However, the revision-3rd and 4th is now enclosed herewith as per annexure-A & B respectively for ready reference. The said guidelines as well as revision thereof issued so far are available on the website of CPCB i.e. (cpcb.nic.in).

In view of above, it is advised to strictly comply with the above mentioned revised guidelines issued by CPCB so far for proper Handling, Treatment, and Disposal of Waste Generated during Treatment/Diagnosis/Quarantine of COVID-19 Patients.
