
Kindly refer to the subject noted above.

In this connection, it is intimated that the Central Pollution Control Board on 18th March 2020 had issued guidelines for management of waste generated during diagnostics and treatment of COVID-19 suspected/confirmed patients which is to be followed by every hospital, isolation centres, laboratories and common bio-medical waste treatment and disposal facilities. Copy of the same was circulated by Haryana State Pollution Control Board to all the Stockholders/concerned Vide letter No.HSPCB/HQ/SWM/2020/1243-84 dated 23/3/2020.

Now, the aforesaid CPCB guidelines for "Handling, Treatment, and Disposal of Waste Generated during Treatment/Diagnosis/Quarantine of COVID-19 Patients" has been revised on 25th March 2020 wherein specific responsibilities of Urban Local Bodies, State Pollution Control Boards/Pollution Control Committees and a person operating quarantine camps/quarantine home/Homecare units have been incorporated.

These Guidelines for handling, treatment and disposal of COVID-19 waste are hereby advised to be strictly complied with at Healthcare Facilities, Quarantine Camps/ Quarantine-homes/ Home-care, Sample Collection Centres, Laboratories, SPCBs/PCCs, ULBs and CBWTFs. Copy of guidelines is enclosed herewith for ready reference.


