## Office Order

Whereas, Inspection policy was circulated vide Head Office order Endst. No. HSPCB/PLG-142/2016/5371-95 dated 24.02.2016 wherein the periodicity for inspection/sampling of the industries/projects covered under Red and Orange categories was prescribed under Para no. 4.2.4;

Whereas, after coverage of Green Category of the industries/projects under consent management vide Head Office Order Endst. No. HSPCB/PLG-135/2016/546-572 dated 14.07.2016, the periodicity for inspection/sampling of Green category of industries/projects for mandatory inspection was prescribed for 07 years vide order Endst. No. HSPCB/2017/3145-3170 dated 07.03.2017 in partial modification/amendment in the Para no. 4.2 of the above said inspection policy of the Board;

Whereas, Government of Haryana has recommended to exempt Green Industries with a history of satisfactory compliance, from Environmental compliance inspection or allow self certification in lieu of conducting physical inspection;

Whereas, in view of above, it has been decided that those Green category of industries/projects may be exempted from environmental compliance inspections which have a history of satisfactory compliance of environmental laws and prescribed norms during the last 10 years or last 03 consecutive inspections arising either from mandatory inspection or any kind of other inspections conducted by the Board officials or which have installed the online monitoring system for effluents/air emissions showing compliance of prescribed standards subject to submission of self certification on yearly basis in lieu of conducting physical inspection regarding satisfactory compliance of environmental laws and prescribed norms as per the requirement of EoDB framework of DIPP Govt. of India; and,

In view of this and partial modification/amendment in the Para no. 4.2.4 of inspection policy as mentioned above, the periodicity for inspection/sampling of Green category of industries/projects for mandatory inspection, prescribed for 07 years is hereby withdrawn and those Green Category of industries, which have a history of satisfactory compliance of environmental laws and prescribed norms of last 10 years or last 03 consecutive inspections arising either from mandatory inspection or any kind of other inspections conducted by the Board officials or which have installed the online monitoring system for effluents/air emissions showing compliance of prescribed standards, are exempted from environmental compliance inspection, subject to submission of self certification on yearly basis in lieu of conducting physical inspection regarding satisfactory compliance of environmental laws and prescribed norms. However, above exemption will not affect the inspections to be conducted in case of any complaint/court/tribunal orders.

This order shall come into force with immediate effect.
