### Brief on general scheme of collection



- Keeping in view our sales volume and generation of e-waste as per our future e-waste targets and our expansion plan we have decided to follow these mechanisms in our organization for collection of e-waste.
  - As per our agreement with M/S E-WASTE RECYCLERS INDIA if any customer wants to handover their old product they can reach on EWRI Management on Toll Free No 18001025679. EWRI representatives explain them about process of disposal of e-waste. Also EWRI will offer to them incentives, coupon, Buy back scheme on the product. If any customer wants to handover the e-waste from their door steps. The logistics team of M/S E-WASTE RECYCLERS INDIA go and collect the items from home and channelize the same to collection centres and on weekly basis they further proceed to final recycling unit in Haryana.

If customers drop the product to nearest collection centre, the waste is channelized to EWRI Haryana unit for disposal.
