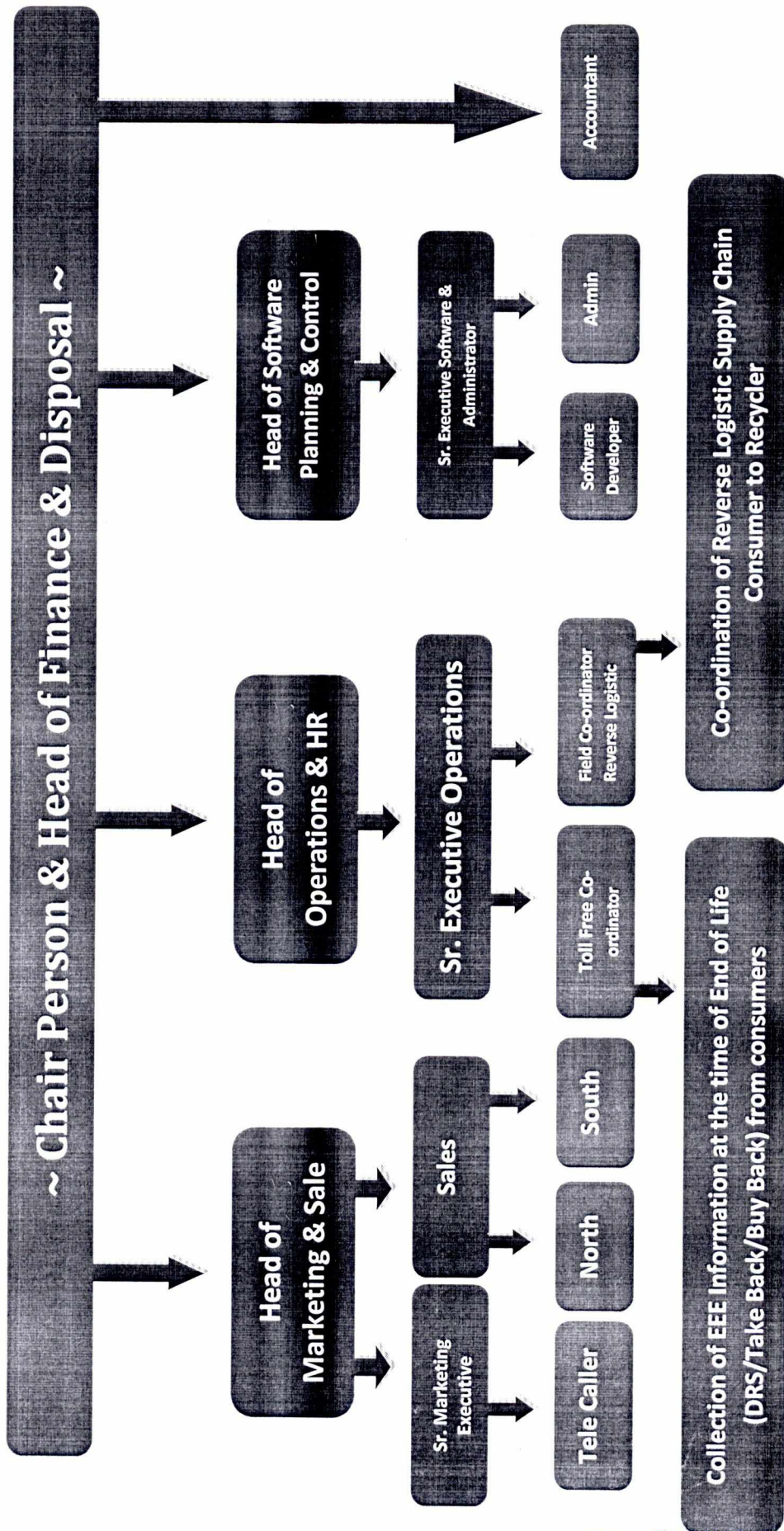

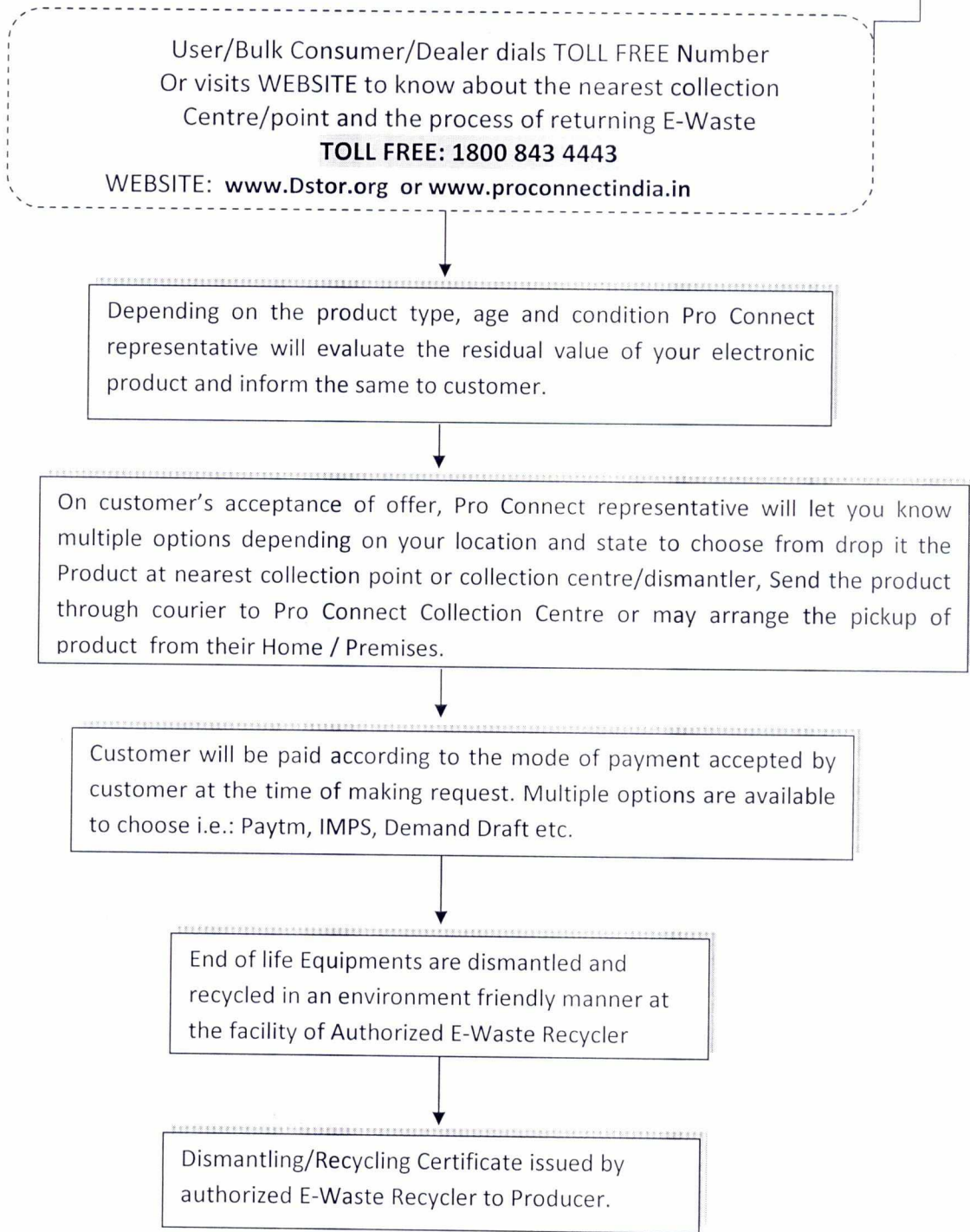

## 7. Whether all states are covered

Yes, with the help of our collection points and our PRO named **Pro connect** network and their tie –up with dismantlers/ recyclers /courier companies etc., we are able to cover all states.

Our PRO has divided whole India in seven zones for our reverse logistic operations. **North East (A), North (B), West (C), Central (D), South West (E), South (F) & Eastern (G)**. Our consumers / customers can call on our/PRO's toll free no. and our PRO's executive will inform them our nearest collection point's address according to the zone. Our Consumer / customer can also drop the consignment at their nearest DTDC Service Point or request for pick up from their premise. Then the E-waste collected through this channel will send to nearest authorised dismantler/ recycler.

Below are the list of some Collection points provided by DTDC covering each state and Union Territory of India. These lists have 2 collection points provided by them but overall DTDC is providing **8900 collection point** across India. 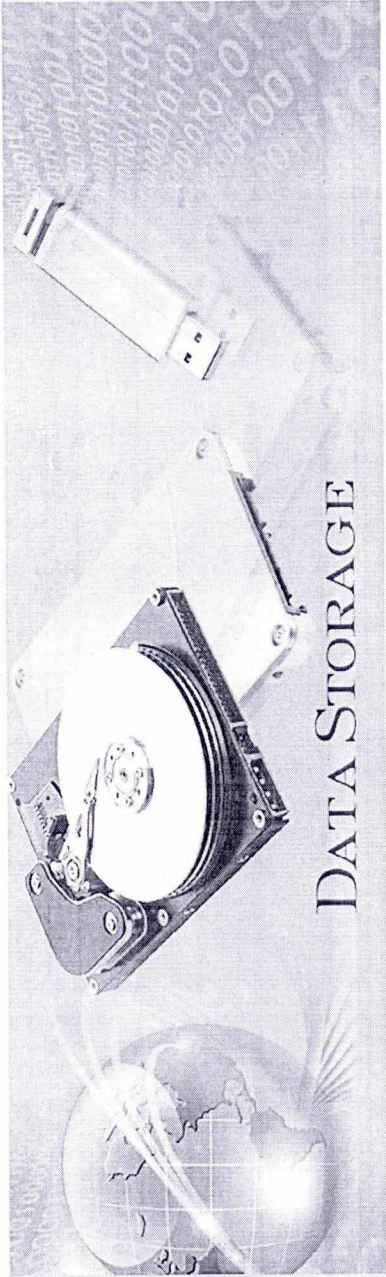
