We hereby submit our EPR plan having details about general scheme of collection, channelization plan, RoHS compliance details.

### **Detail of our Authorized dismantler/ recycler and PRO**

We engaged M/s. Namo e-Waste Management Ltd. Mile Stone, Faridabad, 14/1, Mathura Rd, Faridabad, Haryana 121003 as a PRO and as recycler/ dismantler. It has dismantling capacity 5796 MTA, registered with HPCB for management and dismantling/ recycler of all our e- waste. M/s. Namo e-Waste Management Ltd. has also applied for PRO to CPCB.

As a part of agreement, M/s Namo E-Waste Management Ltd. will collect all our e- waste generated from PAN India.

Our PRO having 23 collection centers in main States of India. For channelization of e-waste, PRO has logistic services that help in transportation of our e-waste from collection centers to recycling/dismantling unit.

We use PAN India basis collection centers/ points of our authorized dismantler/ recycler as per our agreement. Details of the same are provided on the Annexure I.

Rest of the States (North-east) and cities will be covered through logistics service of our authorized dismantler/ recycler. (Agreement copy with logistic partner is attached)

## 1. Plan for achieving collection targets

### a. Mechanism of collection of e-waste:

- i. Consumers can call on toll free number **1800-123-5124** to know about our collection schemes, collection centers & other information related with our products and their disposal after end of life.
- ii. Our PRO/authorized dismantler's logistic service will collect from our consumer or where collection centers/points are not available and shipped to dismantling unit.
- iii. Using this number, consumers get aware about addresses of our PRO/dismantler's collection centers. Consumer can deposit their e-waste at our dismantler's collection centers from where it goes directly to the authorized dismantling unit through dismantler/PRO's logistic partner.

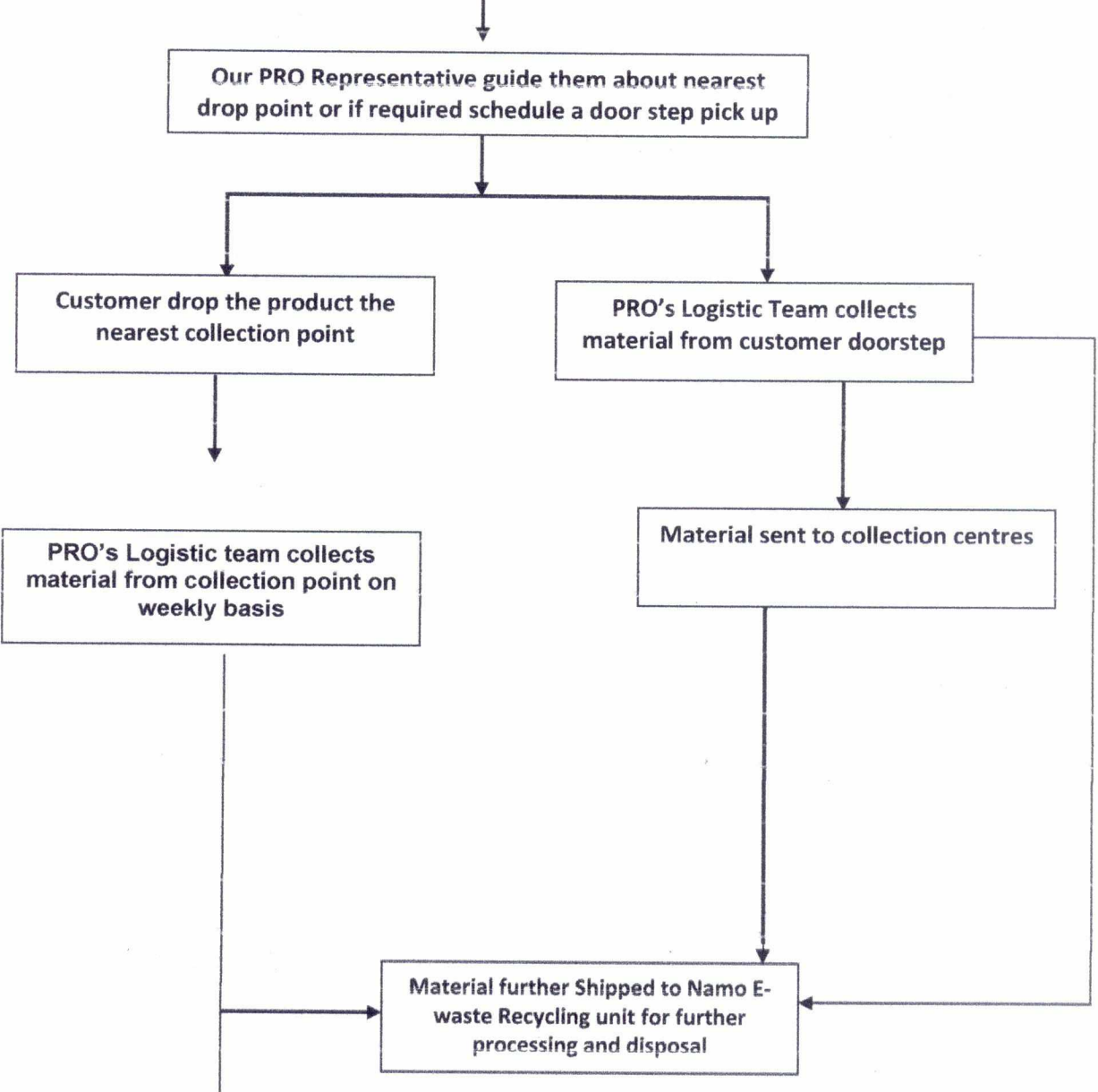
**3. Awareness/ Training Programs:**
