



### **Brief on General Scheme of Collection**

Kyocera Sells its products (Category ITEW6 & ITEW7) in all the states of INDIA through its partners and also through Kyocera Direct Operations. All the Customers are educated that the products which they have purchased are covered under E-Waste (Management) Rules, 2016 which means these products needs to be returned to the Kyocera designated Mini Collection Centers once these products life comes to an end. Kyocera offers Buy Back Discount to all the customers who want to purchase new Kyocera Products in lieu of the return of their old end of life products. All the customers are also educated through E-mail, Advertisement in Local Newspapers, Business Magazines, Product Road Shows, and Partner Meet etc. that all the Kyocera Products are covered under E-waste (Management) Rules, 2016 and that they are required to be returned to Kyocera once their products life comes to end.

All the Kyocera owned products which are placed at the customer place are also returned to Kyocera Document Solutions India Pvt. Limited once these products life comes to an end. These products are then sent to the Mini Collection Center.

All these end of life products will be temporally stored at our Mini Collection Center and once 1-2 Tons of E-Waste is collected in the Mini Collection Center then this E-waste will be transported to our regional collection center.

Once 4-5 Tons of E-waste is collected in our Regional Collection Center, then the entire E-Waste will be handed over to our 3<sup>rd</sup> party Recycler named "SIMS Recycling Solution India Pvt Limited". SIMS will further destroy all the E-waste collected from Kyocera as per the applicable laws and issues destruction Certificate to Kyocera.

### **Details of Collection Centers (Name, Address and Toll Free Numbers)**

Kyocera has defined the collection center as

- a) Mini Collection Center—temporally storage of the E-waste and also where the users can send Kyocera end of life products as E-waste.
- b) Regional Collection Center—This is our Main Collection center which receives E-waste from
  - a. Mini Collection Center.
  - b. Users can also send Kyocera end of life product as E-waste.

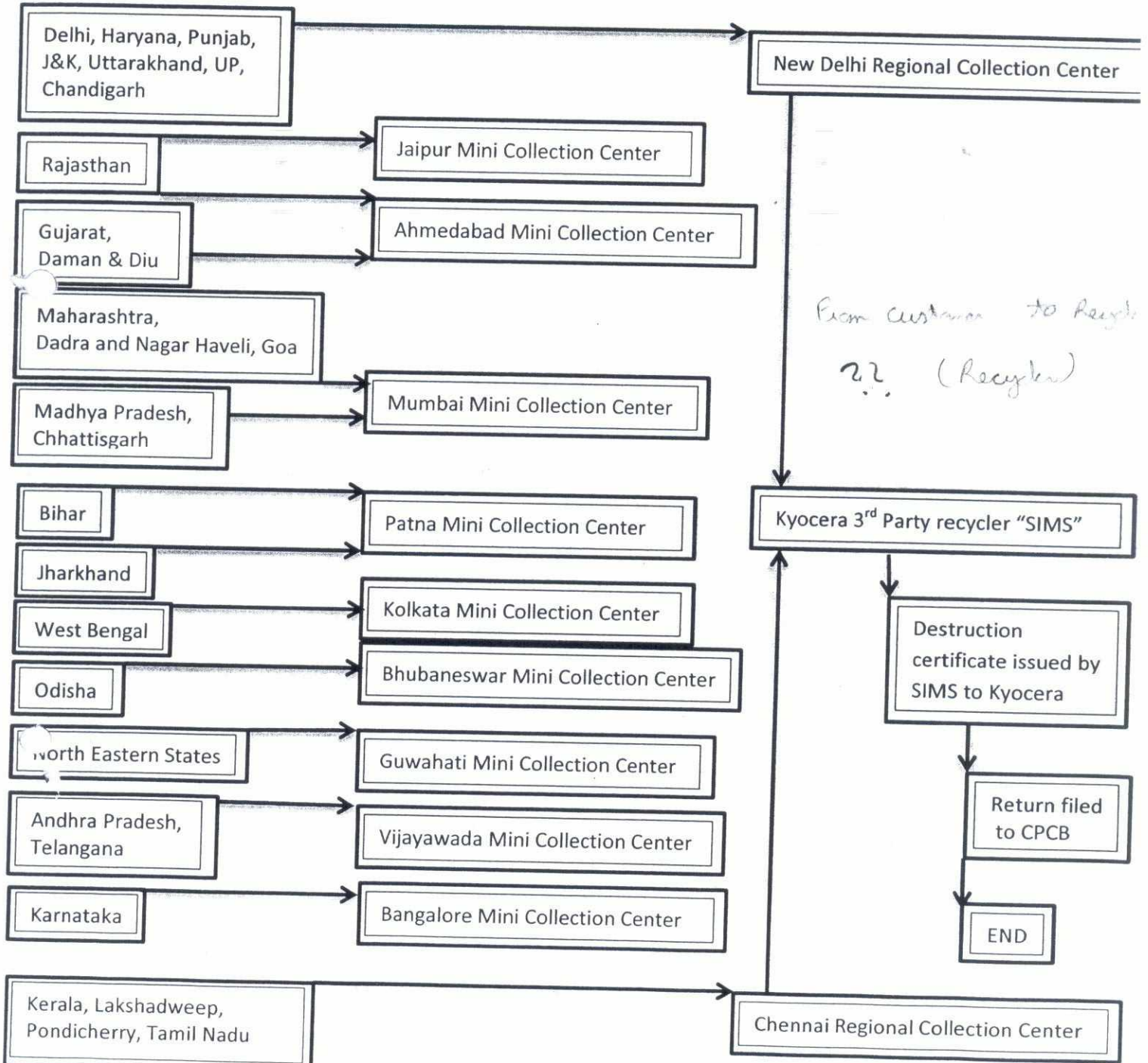
Once 4-5 Tons of E-waste is collected in the Regional Collection Center then all the E-waste will be picked up by our 3<sup>rd</sup> party Recycler from each regional collection center.

- 2) Kyocera also offer Buy-Back offer to all its customers in which we offer Buy-back discount ranging from Rs 2000 to Rs 10000.
- 3) We will also encourage customer to return his Kyocera products once their life comes to end (as E-waste) in return of residual value of his E-waste.

- 3) We will also send E-mail to all our customers that the products which they have purchased needs to be returned to Kyocera as per E-Waste (Management) Rules, 2016.
- 4) We will educate all of our customers through our various product shows, partners meet etc.

Kyocera will invest around 5 Lac for its buy-back and residual value collection schemes.

**Collection Centers**

Kyocera has marked the reserved space for the storage of E-waste which will be collected in our Mini and Regional Collection Centers and we will invest about 10 Lac on yearly basis.

**Channelization (Including cost of reverse logistics)**

Kyocera will incur around 10 Lac as the cost of transportation of E-waste from mini collection center to regional collection center.

**Recyclers/Dismantlers**

Kyocera will invest around 10 Lac for the proper recyclers/dismantlers of E-Waste generated with the help of our 3<sup>rd</sup> party recycler.

**RoHS testing**

For all the products, RoHS testing is currently being carried out by our Principal- Kyocera Japan at their own cost.

KDID will also incur all the testing cost as per the rules and guidelines mentioned in the E-Waste (Management) Rules, 2016.

We don't have any other awareness scheme and will update CPCB if any other Awareness or Collection Scheme introduced in future.
