Brief on general scheme of collection

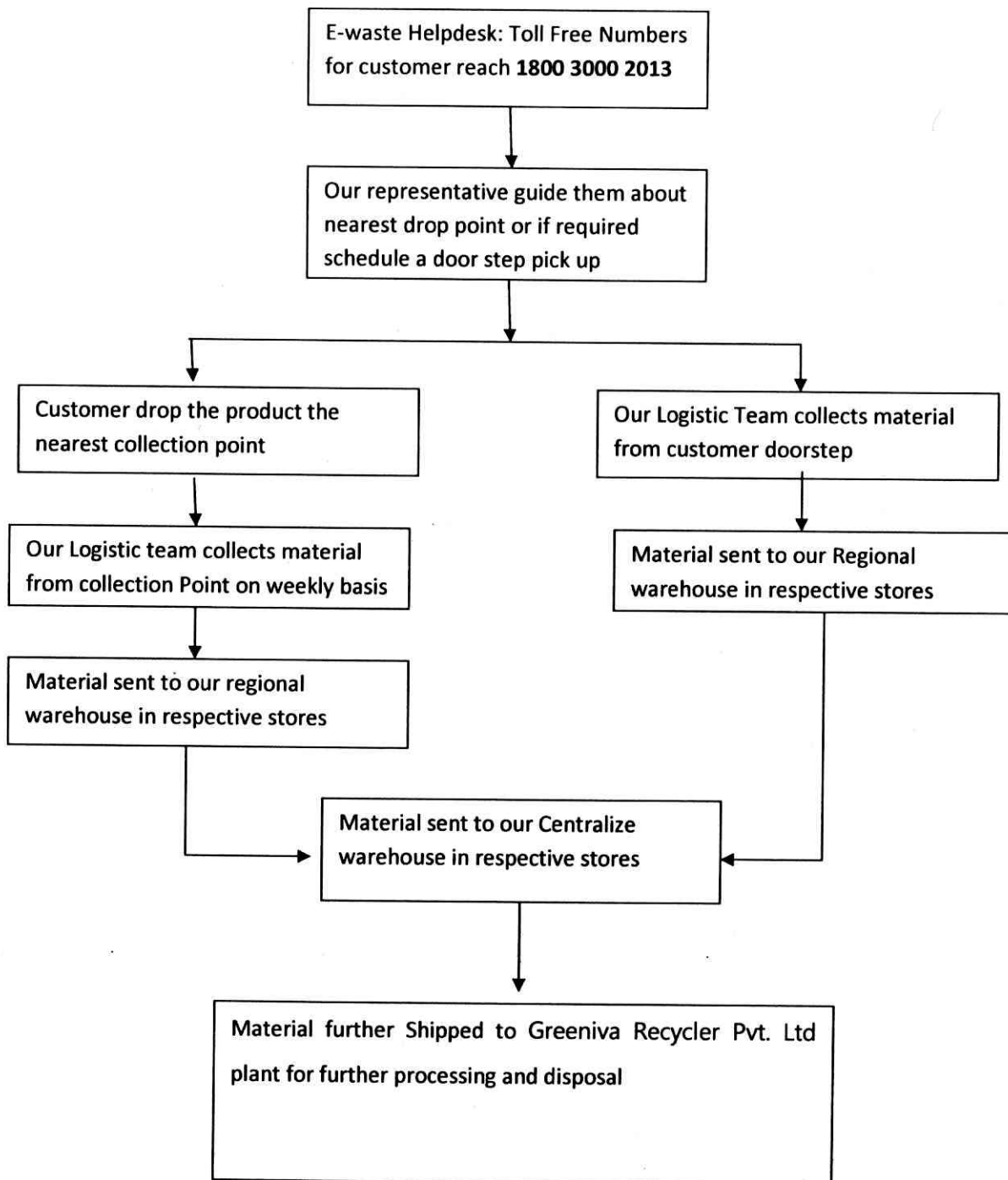
- Greeniva Recycler Pvt. Ltd collects all our E-waste generated from PAN India and disposes the same at their plant in Ghaziabad (UP).

Specific Collection Schemes (Buyback, Exchange, DRS, etc.):

BuyBack:

We will have a mechanism of incentivizing customer who wants to return their end of life product (e-waste), whereby any of our consumers want to discard their product. They call on our E-waste helpdesk. Once any call received by our E-waste helpdesk. our team directly calls them and makes an arrangement to collect the end of life product from their door step and depending upon life of product.
