# 3. The Authorisation shall be valid for a period of five (5) years from the date of issue with following conditions:

i. You shall strictly follow the approved Extended Producer Responsibility Plan, a copy of which is enclosed herewith as Enclosure-I

You shall ensure that collection mechanism or centre or points are set up or designated as per the details given in the Extended Producer Responsibility Plan and that shall be completed before the proposed dates if any in the EPR Plan.

iii. You shall ensure that all the collected e-waste is channelized to your authorised recyclers/ dismantlers M/s TES-AMM Recyclers India Pvt. Ltd., A-18, SIPCOT Industrial Growth, Centre Panrutti 'A' Village Orgadam, Sriperumbudur Taluk, Kancheepuram, Tamilnadu - 631 604, M/s. Eco Recycling Limited (Ecoreco), 422, The Summit Business Bay, Near Gurunanak Pump, Andheri Kurla Road, Andheri (E), Mumbai and M/s. E- Parisaraa Private Limited, B-41/1, Peenya Industrial Area, 3<sup>rd</sup> Stage, Bengaluru, Karnataka 560058 and records shall be maintained both at recyclers end as well as at your end.

iv. You shall maintain records, in Form-2 of these Rules of e-waste and make such records available for scrutiny by Central Pollution Control Board as and when directed;

v. You shall file annual returns in Form-3 to the Central Pollution Control Board on or before 30th day of June following the financial year to which that returns relates;

# vi. General Terms & Conditions of the Authorisation:

- The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2016 made there under;
- b. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Central Pollution Control Board;
- Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board within 15 days on which decision shall be communicated by Central Pollution Control Board within sixty days;
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points or any other facility which are part of the EPR plan.
- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Central Board reserves right to cancel/amend/revoke the authorisation at any time as per the policy of the Central Board or as notified by the Government from time to time.

#### vii. Additional Conditions:

- a. Whenever RoHS sampling and testing will be carried out by CPCB, you have to bear the cost of equipment Personal Computing: Laptop Computers (ITEW4), Personal Computing: Notepad Computers (ITEW 5), Printer including cartridge (ITEW6), Cellular Telephone (Feature and Smart Phones) (ITEW15), Television Sets (including sets based on LCD and LED Technology, CRT)(CEEW1), Refrigerator (CEEW2), Washing Machine (ITEW3), Air conditioners excluding centralised air conditioning plants (CEEW4) and the cost of testing as per Rule 16 (9) of the E-Waste (Management) Rules, 2016;
- b. That the applicant will submit revised application for grant of EPR Authorization, when it will engage any PRO or change its EPR Plan;
- c. That the applicant has to ensure that e-waste collected at collection centres and points mentioned in the application should reach to your authorized dismantler/recycler;
- d. That the applicant has to submit to CPCB every quarter the amount of (in number or weight) of e-waste of EEE Code –ITEW4, ITEW 5, ITEW 6, ITEW15 (Feature and Smart Phones), CEEW1, CEEW2, CEEW3 and CEEW4 and collected in that quarter and recycled;
- e. That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- f. In case of any violation of the above condition, your authorization will be suspended/cancelled;
