It is for the information of all concerned regarding conducting the Public Hearing for considering grant of Environmental Clearance for the existing unit named M/s Bankey Bihari Overseas Pvt Ltd., Sampla, Beri Road, Village, Ismaila, Tehsil Sampla, District Rohtak, Haryana, established for manufacturing of Formaldehyde under the violation category, as the unit was established without necessary prior Environmental Clearance, thus violating the provisions of EIA Notification, 2006, and for considering its expansion from 80 MT per day to 250 MT per day.

The project is covered under the category A of item 5 (f) "Synthetic Organic Chemicals" of the schedule to the EIA notification dated 14th September 2006, issued by Ministry of Environment, Forests and Climate Change, Govt. of India, New Delhi, requiring prior EC from Expert Appraisal Committee, MoEF&CC, and thus Environmental Clearance is mandatory for the project and its expansion. The project proponent will be liable to comply with the conditions / penalty / prosecution action, as imposed / provided by Government of India or any competent agency in this regard.

The project proponent has applied to the authority for Environmental Clearance for the existing unit under violation category and for expansion as mentioned above, and the **public hearing has been fixed on 09.11.2021 at 11.30 AM onwards at the factory site.**
