Public Hearing was conducted by Haryana State Pollution Control Board on 09.06.2022 for proposed project "Manufacturing technical grade pesticides by M/s Shree Ram Agro India at Unit – 2 as a mandatory requirement under EIA Notification dated 14.09.2006 and amended till date. Notice for public hearing was issued by the Member Secretary, Haryana Pollution Control Board Dated 05th May 2022, wherein date of Public hearing was fixed as 09th June 2022. Wide publicity was given to the public through newspapers and letters to the District Officers & Village Panchayats (Copy of News cutting and notices are attached as Annexure-A).

Accordingly public hearing was conducted on 9th June 2022. The public hearing was attended by the following officers **(List attached as Annexure-B):-**

- 1. Sh. Anubhav Mehta, Sub-Divisional Magistrate, Karnal
- 2. Sh. Shailendra Arora, Regional Officer, HSPCB, Karnal,
- 3. Sh. Ramesh Kumar, Junior Draftman, DTP, Karnal
- 4. Sh. Rajesh District Industry Centre , Karnal

A large number of inhabitants of the area as well as adjoining area participated in the public hearing whose name are recorded and enclosed herewith as **(List attached as Annexure-C)**. The entire proceeding of the public hearing were photographed and video graphed. The Copies of DVD and photographs are enclosed **as Annexure-D**. Copy of the executive summary of the EIA for "Environmental Clearance for proposed

project" were distributed to the audience present in the hearing.

Sh. Anubhav Mehta SDM Karnal presided over this hearing held on 09/06/2022 Sh. Shailender Arora, Regional officer, HSPCB, Karnal Region, welcomed SDM Karnal, Other officers of the District Administration, Panches, & Sarpanches of surrounding area and public present in the hearing. He explained about the necessity of the public hearing being held under provision of EIA notification of 2006, amended to date. He detailed

He particularly emphasized that those present in the hearing should raise their quarries/suggestion/objection regarding any problem which may crop after commissioning of this project. He added that Haryana State Pollution Control Board is bounded to implement Environmental Laws i.e. water Act/Air Act.

Further, Formal permission to inaugurate the process of public hearing was granted by the Chairperson Sh. Anubhav Mehta SDM Karnal.

Thereafter Sh. Shailender Arora Regional Officer, HSPCB, Karnal Region requested Sh. Vikrant Mahendran Wolkem India Limited (Environment Consultant) of M/s Shree Ram Agro India to give the presentation of the project in detail and remedies taken by the project proponent to control the environmental impacts which may arise after expansion of the existing project.

Mr. Vikrant Mahendran, described the details of Proposed Project, which are as under:

- 1. The total land of proposed projects is 19874.263 Sq.Ft.
- 2. The total cost of proposed project is 8.06 Crores.
- 3. The total production capacity of proposed project "M/s Shree Ram Agro India" is 300MTPA.
- 4. Baseline Study of Proposed project M/s Shree Ram Agro India is conducted from 01st December 2020 to 28th February 2021 by Wolkem India Limited, Environment Laboratory duly accredited by NABL and recognized by MoEF&CC, New Delhi.
- 5. The total power requirement of proposed project (M/s Shree Ram Agro India) will be 580 KVA and source from UHBVN (Uttar Haryana Bizali Vitaran Nigam).
- The total water requirement of proposed project (M/s Shree Ram Agro Limited) is 23.65 KLD out of which 13.7 KLD will be recycled. Hence, 9.95 KLD fresh water will be required for proposed project.
- 7. The Total wastewater generation shall be 18.03 KLD. Industrial effluent 13.03 KLD will be treated at ETP, MEE and RO and will be reuse in process, Boiler, cooling tower, scrubber, reactor washing. Domestic waste water 5KLD will be collected in separate collection tank and sand to ETP and mixed with Stream-B for further treatment.
- 8. Proposed Project required 0.6TPHcapacity boiler.
- 9. 2 MT/Day Risk Husk Briquette will be used for Boiler as a fuel.
- 10. The total 2 technical grade pesticide products will be manufactured by M/s Shree Ram Agro India, List of Product, type and capacity is tabulated in below table:

Domestic waste water will be sent to STP for aerobic and anaerobic treatment and reused in plantation.

- Total wastewater generation shall be 18.03 KLD. Industrial effluent 13.03 KLD will be treated at ETP, MEE and RO and will be reuse in process, Boiler, cooling tower, scrubber, reactor washing. Domestic waste water 5KLD will be collected in separate collection tank and sand to ETP and mixed with Stream-B for further treatment.
- PPEs Like Earmuffs/plugs would be used while running the equipment in high noise area.
- Noise generating equipment's like DG Set will be provided with acoustic enclosure to control noise level within the prescribed limit.
- Green belt will be developed within premises of plant to absorb the noise.
- Good maintenance practices will be adopted by plant management authorities for plant machinery and equipment, which will help to avert potential noise problems.
