

Copies of the presentation in Hindi of Draft EiA of M/s Goyal Overseas at Project Site Plot No. 22//10, 11/2, 20/1/1, Village Shchzadpur, Tehsil Jagadhri District- Yamunanagar, Haryana were distributed to the officials and other present in the hearing.

At the onset of Public Hearing, Nirmal Kumar, Regional Officer, Yamunanagar, Haryana State Pollution Control Board welcomed the Chairperson Sh. Shushil Kumar, HCS, SDM, Jagaord Yamunanagar and other officers of the District Administration, Panches & Sarpanches of surrounding area and public present in the hearing.

Further formal permission to inaugurate the process of Public Hearing was granted by the Chairperson Sh. Shushil Kumar, HCS, SDM, Jagadhri, Yamunanagar. The Regional Officer, HSPCB briefed about the necessity of the public hearing being held under provision of CIA Notification of dated 14<sup>th</sup> September, 2006, amended to date and submitted the present unit is a Formaldehyde manufacturing unit and covered at Sr. no. 5 (f) of the Schedule of the CIA Notification of dated 14<sup>th</sup> September, 2006. He further submitted that present unit is already established for the capacity of 15 MT/Day and for this obtain the desired Environmental Clearance as per EIA Notification 14.06.2006 and consequently action has been taken under Environment Protection Act, 1986 against the unit.



Sub Divisional Officer (C . Jagadhri Thereafter, Regional Officer, HSPCB requested project consultant to make the presentation for the project for information of all the people present.

Mr. Pawan Kumar Verma of Vardan Environet has given the detailed presentation as under: He informed thatanapplication was filed by M/s. Goyal Overseas with the MoEF&CC, New Delhi forgetting Environmental Clearance under EIA notification no. 1533 (E) dated 14.9.2006 forProposed Capacity Expansion in Formaldehyde Manufacturing Unit in Existing Facility from 15 TPD to 100 TPD at Village- Village Shehzadpur, Tehsil Jagadhri District- Yamunanagar, Haryana.

After considering the application of the project, the MoEF&CC, New Delhi had issued Terms of Reference to the project for preparation of draftElAstudy report. Now, the proponent has submitted draft EIA report to the Haryana State PollutionControl Board for conducting public hearing of the projectas per the procedure prescribed in theEIA Notification dated 14.09.2006.

Mr. Pawan Kumar Verma, Senior Manager, EIA of M/s Vardan Environet, Environmental Consultant of the project proponent brought outthe details of the project before the public.

After the presentation the Regional Officer, HSPCB asked the public to submit their objections/queries/clarifications regarding project or they want any other information the same will be provided or clarified by the project proponent at site.
