## 1. Background

As per EIA Notification of MoEF&CC, GOI,14th September 2006 & its subsequent amendments till date,the project falls under Category 'B1' and requires Environment Clearance (EC) from SEAC/SEIAA before the commencement of any ground Activity related to Mining,Public hearing is required for such project as per EIA notification for brining any suggestion & Objection related to environment before obtaining Environment Clearance form SEIAA,Haryana.

The project Proponent applied in the head office of Haryana State Pollution Control Board on 31.08.2023 along with the prescribed fee for conducting public hearing. The Date of Public hearing was fixed by Deputy Commissioner, Karnal on 25.10.2023 at 02:00 pm at project site vide letter no. 22352/MA dated 08.09.2023.

At the very outset Sh. Shailender Arora, Regional Officer, Haryana state Pollution Control Board, Karnal Region welcomed the Sh. Ashok Kumar, Sub Divisional Magistrate, Indri and other officers of the District Administration and all the persons from the nearest Villages present in the public hearing. He then requested Sub Divisional, Indri for the permission to start the proceeding of the Public Hearing.

After obtaining the permission from the chair to start the proceedings of the Public Hearing ,Regional officer ,HSPCB Karnal Region briefed about the requirement of conducting Public hearing as per the provision of EIA notification 14.09.2006 for the proposed project of Mining of Sand capacity 35,60,000 TPA at over an area of 82.85 ha located at villagesNangal(North),Nangal(South),Tatarpur&KamalpurGadianDistrict

Karnal as the project falls under Schedule 1(a) Mining of Minerals under the schedule of EIA Notification ,2006 and categorization as category B.

The Regional Officer ,HSPCB Further informed that notice of public Hearing was published in national News paper in Hindi and English & the copies of EIA report were kept in the office of Deputy Commissioner ,Karnal ,Regional office, HSPCB ,Karnal .Office of Chairman Zila Parishad ,Karnal .EO,MC ,Karnal& DDPO ,Karnal for reading of the General Public and for inviting comments if any and no written as well as verbal complaint has been received.

After that he asked the Representative EIA Consultant of Project Proponent M/s P and M Solution (Environment Consultant) to give detailed presentation on the project.

Then, Mr Rajesh Kumar Vishwas ,on behalf of M/s P and M Solution ,EIA Consultant of the project Proponent has given the detailed presentation.

He informed that an application was filled by M/s Chaudhary Transport Company. With the SEIAA,Haryana for getting Environment Clearance under EIA Notification no 1533 (E) dated 14.09.2023 for the proposed Project of Mining of Sand Minor Minerals capacity 35,60,000 TPA over an area of 82.85 ha located at villages villagesNangal(North),Nangal(South),Tatarpur&KamalpurGadian, District – Karnal ,Haryana.

After considering the application of the PP, theSEIAA, Haryana has issued 'Terms of Reference" to the project vide letter no SEIAA/HR/2023/393 Dated21.08.2023 for preparation of the Draft EIA study report. Now, the proponent has submitted Draft EIA report to HSPCB for conducting public hearing of the project as per the procedure prescribed in the EIA Notification dated 14.09.2006.
