14th review meeting of the RRC was held on 07.10.2022 through VC among the DG, Industries Department, DG, ULBD, Director Environment and Member Secretary, HSPCB. Following were present:-

- 1. Sh. Shekhar Vidyarthi, IAS, DG, Industries & Commerce Department.
- 2. Sh. DK Bahera, IAS, Director, ULBD, Haryana.
- 3. Sh. Pardeep Kumar, IAS, Director, Environment and Member Secretary, HSPCB

The progress report submitted by the Stake Holder Departments was reviewed and the brief proceedings are as under:-

- The issue of tapping of sewage and putting it into existing sewer was discussed. Some of the departments have not sent the Action Plan for respective locations. The details are attached herewith.
- Regarding achieving Faecal Coliform Standard, the departments have not achieved the same so far though it was to be achieved by 02.07.2021.

The above issues shall be placed before the Chief Secretary, Haryan in the coming meeting to be held on 10.10.2022 at 11:00 AM in Main Secretariat, Chandigarh. Some of the departments have not submitted the latest updated status of the activities mentioned in the agenda. The same is reproduced here in the coming paras so that concerned departments may submit the upated status (if any).

I. Tapping of sewage

Govt. has laid and been laying sewerage network in approved areas for carrying sewage to STPs. But as per NGT direction, the sewage from unauthorized colonies of towns/cities is to be tapped/ diverted at various locations by concerned Departments and put into existing sewers so that it could be treated in existing STPs. The list of the locations of towns/cities where issues need to be resolved is attached as **Annexure-1**.

III. Estimation of sewage generation

The STPs have been constructed considering future population mostly upto 2031. But the waste water generation have been calculated according to population of 2021 and it has been observed that the waste water reaching upto STPs for treatment is higher than the estimated qauntum of sewage in many towns.

So it can be deducted that method used to estimate the capacity of STP to be installed is not true representative of the actual position. This will create problem and without proper planning the river pollution problem shall not be solved. So the concerned departments are to take corrective steps. The detail of the towns is given in following tables:-

VI. Status of laying of sewer network in approved/notified areas

2225 Km of sewer line was proposed to be laid in total 61 towns in the State of Haryana, out of which 2029 Km length of sewer line have already been laid. Sewerage completely laid in 53 towns. Sewer lines are being laying in balance 8 towns and status of the same is as under:-

VII. Sludge disposal for STPs.

The STP sludge management has not been scientific so far. The sludge is nothing but aggregated mass of pollutants and can not be left unattended or it will pollute environment again. A lot of cost is incurred in removing these pollutants from water environment. So, this issue needs to be addressed. If the sludge is hazardous then it should be disposed as per HOWM Rules. The Concerned Departments should review for disposal of sludge for their respective STPs.

(Action by ULBD, HSVP and PHED)

VIII. Under construction and Proposed CETPs

HSIIDC has submitted action plan for CETPs and they should not delay their action. Further, the work of CETPs at Faridabad has not been started so far by ULBD. The construction of CETP at Gurugram has not been started. It was decided during the last review meeting held on 06.05.2022 under the Chairmanship of Chief Secretary, Haryana that the work for construction of CETP at Gurugram be done by the MCG and they will submit their timelines and action plan immediately in this regard. But no action plan has been received from MCG so far.

IX. Online Monitoring Devices (OMDs) on STPs

The OMDs were to be installed and data displayed by 31.03.2019 as per action plan submitted before NGT, but 79 STPs are still not displaying the data of OMDs. The data of other STPs has not been validated so far. The Concerned Department should look into it.

(Action by ULBD, HSVP, GMDA and PHED)

X. Dredging and de-silting of drains in the cities

The Action Plan was submitted by Irrigation Department for cleaning/de-silting of drains for Ghaggar catchment. But action plan for current financial year for cleaning/de-silting of drains for Yamuna catchment not received.

(Action by Irrigation Deptt.)

XI. Plan for integrated Solid Waste Management (ISWM).

Only one ISWM (Waste to Energy plant, Sonepat) has been commissioned so far. Timelines for Faridabad-Gurugram cluster has been submitted as Dec, 2023 by ULBD. The Time Bound Action Plan not submitted for 11clusters.

XII. Plan for plastic waste management by HSPCB/ULBD

The action plan was submitted but latest status needs to be updated. The updated action plan for PWM should be submitted by ULBD.

XIII. Crop Diversification/inter Cropping for water conservation

Following issues were enumerated in action plan by Agriculture Department for Water Conservation so that pressure of river water extraction is minimum:-

- 1. Area reduction under technology of innovation for establishing alternate crops.
- 2. Farm mechanization
- 3. Cluster demonstration and Agro forestry system
- Underground pipelines
 The work completed so far and future action for above or any newly added scheme should be submitted for monitoring.

(Action by Agriculture Department)

XIV. Water Efficient agriculture Practices

The Irrigation Department had submitted action for promoting of following water efficient agriculture practices:-

- 1. Status of Micro irrigation on STPs is required to be submitted.
- 2. Latest status of reuse of treated waste water should be submitted.
- 3. The latest status is required for Solar/Grid powered Micro Irrigation project.

(Action by Irrigation Department)

XV. Watershed Management.

The Rural Development Department and Agriculture Department have not submitted for project wise monthly plan for Watershed Management for the year 2022-23.

(Action by Rural and Agriculture Department)

XVI. Increasing the water storage capacity

Irrigation Department has proposed to construct dams on rivers for water storage in catchment of river Yamuna and Ghaggar. Latest status of these dams should be submitted.

(Action by Irrigation Department)

XVII. Greenery Development Plan

Forest Deptt/ HSVP are involved in tree plantation. Forest Department had submitted details of plantation done in 2021-22. But the Geo locations of areas for tree plantations have not been provided so far by the Forest Deptt.

HSVP has not submitted details of Urban Estate wise plantation done in 2021-22 alongwith geo locations.

(Action by HSVP and Forest Department)

XVIII. Ground Water Management

HSVP has under taken water conservation measures. They are implementing dual button cistern systems for housing projects. List of units/occupation certificates where dual button cisterns systems have been installed in Haryana is required to enumerate the action completed as achievements. Further, the HWRA is to submit action plan for Ground Water Management.

(Action by HWRA and HSVP)

XIX. Septage Management/disposal of sewages through tankers

There are complaints of plying of illegal tankers in NCR which collect untreated sewage/ effluent from various industries and discharge into drains or road sides. The ULBD has prepared mechanism to address this issue. But we have

not received any case where vehicle has been impounded and case filed against vehicle by police. Such action is must for creating minimum deterent. CPCB has issued direction under section 18 of Water Act, 1974 and these are binding in nature. CPCB have asked to take action through DGP. The action can be either for violation of ULBD policy or Motor Vehicle Act.

ULBD has submitted that septage Management policy has been notified by all the Municipalities falling in catchment of River Ghaggar and Yamuna. 242 Nos. tankers have been registered/deployed in the MCs falling in the catchment of River Yamuna & 68 nos. tankers have been registered/deployed in the MCs falling in the catchment of River Ghaggar. MCs have also started challaning of the tankers disposing septage illegally. MCs have also started challaning of the tankers disposing septage illegally. From the month of June, 2020 to till date, 397 nos. of tankers have been challaned and penalty of Rs. 77,84,000/- has also been recovered from the violators out of which 03 Challans amounting to Rs. 15000/- were issued in month of Aug, 2022.

(Action by ULBD and Haryana Police)

XX. Organization of Health Camp

Health Department has not submitted monthly report alongwith action plan for future.

(Action by Health Department)

XXI. Status of treatment System/ STPs in villages along Rivers Yamuna and Ghaggar.

The Action Plan for sewage of villages having out fall in rivers was prepared after submission of the State Action Plan before NGT and hence, it was not in the original plan. There are 277 villages along Yamuna and 45 villages along Ghaggar.

River Yamuna catchment

The matter of some villages needs attention.

- Timeline expired for 1 village by PHED/D&P.
- Timelines expired for 1 location by D&P.

River Ghaggar catchment

• Timeline expired for 1 village by D&P.

The status of such villages is enclosed as Annexure-4.

The D&P and other concerned Departments have not obtained CTE/ CTO from the HSPCB for treatment system being setup/established. It is worth to mention here that the NGT is reviewing CTO status of STPs in OA No. 887/ 2019-Sukhwanti Vs SoH.

(Action by PHED, GMDA, ULBD and D&P)

XXII. Adverse entry in ACRs of erring officers

DO letter was written by CS to Administrative Secretaries but no information for adverse entry/action against defaulting officers is available. It is matter of fact

that many projects have been delayed and activities not started in some cases. The matter of the fixing of responsibility is absent.

XXIII. Monthly ATRs by SESTFs

The DO letters were written by Chief Secretary to Deputy Commissioners for action against the violators but visible action not being taken by the SESTFs.

XXIV. Action taken for River bed mining

River bed mining should be scientific and the policy in this regard to be implemented. The monthly ATR for violations should be submitted by Mining & Geology Department every month.

(Action by Mining & Geology Department)

XXV. Disconnection of electricity connection and record of defaulting industries from GST Department.

HSPCB files prosecutions against the industries which are operating without CTE and are violating the environmental norms. This has to be established in courts that unit has operated in the past. The sample reports and photographs are the only evidence so far with the Board. But many times, sample report is not available. The operation of unit can be established with electricity consumption/ bills and the GST deposited by it. This record also provides the names of the owners i.e. accused in our case. The Regional Officers of HSPCB face difficulty in obtaining such record from the Field Offices of the Taxation Department and Electricity Department. In some cases, the Taxation Department has submitted reply after 4 years regarding Tax details.

It is worth to mention here that in matter of WP No. 375/2012, Parayaran Suraksha Samiti Vs UOI, Hon'ble Supreme Court has directed that Electricity Department is to comply with directions of State Board for disconnection of electricity.

Electricity Department and Taxation Department were requested to depute 1 Nodal Officer at Head Office to over come the difficulty. But, no response has been received from these departments so far.

(Action by DHBVN and Excise & Taxation Department)

XXVI. OA No. 562 of 2022 Ishika Vs Govt. of NCT of Delhi.

Grievances in this applications is against pollution of River Yamuna.

The Hon'ble NGT has directed vide its order dated 30.08.2022 in the above said case that the Chief Secretaries of Delhi, Haryana and UP are required to ascertain latest factual position and give their report by email within two months with explanation why coercive and penal measure be not taken in terms of fixing accountability for such blatant failure of the authorities in protecting the water quality of River Yamuna, which is tributary of Ganga, by preventing discharge of pollution. The reports of Chef Secretaries may be in a consolidated manner in the light of inter-department review and ground realities.

Delhi, Haryana and UP have to review the situation at higher levels and take remedial action. They may place factual status on progress made in the last one year, whether the higher authorities are satisfied with the same, if not, further plan of action with timelines and fixing accountability, extent of sewage and trade effluent being still discharged. Based on these reports the Tribunal may have to fix accountability of concerned authorities and financial liability for compensation for damage to the environment.

All stakeholders are required to complete their works within time frame as per action plans submitted before NGT.

A DO letter was issued by Chief Secretary, Haryana to Administrative Secretaries on 04.01.2021 for fixing responsibility of erring officers.
