No. 12/17/2002-Env.-III.—In compliance with the judgement of the Punjab and Haryana High Court Order dated the 20th March, 2002, in Civil Writ Petition No. 19911 of 2001 M/s. Balbir Singh & Co. V/s. State of Haryana and others, and in exercise of the powers conferred by Sub-section (1) read with Sub-section (2) of Section 54 of the Air (Prevention and Control of Pollution) Act, 1981 (Act 14 of 1981), and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following rules further to amend the Haryana Air (Prevention and Control of Pollution) Rules, 1983, namely :—

1. (1) These rules may be called the Haryana Air (Prevention and Control of Pollution) Amendment Rules, 2002.
- (2) They shall be deemed to have come into force with effect from 5th December, 1997.

2. In the Haryana Air (Prevention and Control of Pollution) Rules, 1983, in rule 15, in sub-rule (2), in the table under columns 1 and 2, for item A-VII (i) and (ii) and entries thereunder, the following items and entries thereunder shall be substituted, namely :—
