Amendment in the procedure for obtaining one time authorization by the trader unit desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users

Every trader desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users of the same, is required to obtain one time authorization from the State Pollution Control Board under section 13 of the above said Rules.

The procedure was issued vide Head Office letter Endst. No. HSPCB/2016/160-177 dated 14.06.2016 (Annexure-I) for obtaining one time authorization by the traders desirous of import of other wastes, on behalf of actual users, mentioned in Part-D of Schedule-III under Rule-13 of HOWM Rules, 2016. This procedure was approved by the Board in its 176th meeting held on 19.12.2016 vide agenda item no. 176.19 (S).

The proposal for delegation of powers of the Board for grant of the onetime authorization to the traders desirous of import of "Other Wastes" on behalf of actual users under Rules 13 of HOWM Rules, 2016 was also placed before the Board in the same agenda item no. 176.19 (S) but the approval of the Board does not find mention about the authority regarding delegation of powers for grant of such authorization. Presently one time authorization to the traders desirous of import of "Other Wastes" on behalf of actual users under Rules 13 of HOWM Rules, 2016 is being granted at the level of Chairman which needs ex-post facto approval of the Board.

Now the procedure has further been examined in view of the following issues being faced while processing the applications for grant of above said one time authorization:-

- 1. The "Other Wastes" mentioned in the Part-D of Schedule-III of the HOWM Rules, 2016 has been included for the first time for obtaining specific authorization for their utilization as a resource under these Rules but standard operating procedure has yet not been prescribed/issued so far by Central Pollution Control Board for utilization of most of the "Other Wastes" mentioned in Part-D of Schedule-III, as a resource which is pre-requisite for grant of authorization to actual users of such "Other Wastes".
- As per prescribed check list of documents VAT/TIN number certificate was one of the document required for obtaining authorization but after introduction of GST in place of VAT and other taxes, the check list of documents is further required to be amended.
- 3. In most of the cases the detail of raw materials used by actual users of "Other Wastes" is not provided in the relevant documents submitted by the applicants-traders due to which this information is

taken from concerned Regional Officers which causing delay in deciding such applications.

In view of above, the amendment in above said procedure was issued vide this office letter no. 2918-37 dated 03.01.2018 (Annexure-II) wherein it has been decided that the new applications for one time authorization of the traders, importing other wastes, on behalf of actual users, mentioned in Part D of Schedule-III under HOWM Rules, 2016, shall be submitted to the concerned Regional Office of Haryana State Pollution Control Board instead of submitting the application directly in Head Office who will submit recommendation to Head Office as per prescribed procedure after verifying the details of the applications received including type and quantity of other wastes, for which authorization has been sought for import, used by the actual users mentioned in the application as per information available in the OCMMS in case actual user exists in Haryana and authenticated from other State Pollution Control Board in case actual user exists in other State.

It has also been decided that conditional one time authorization may be granted to the traders desirous of import of other wastes (**) mentioned in Part-D of Schedule-III, on behalf of actual users, who apply for the same to the Board, without asking for specific authorization of actual users for utilization of such other wastes mentioned in the procedure circulated vide letter dated 14.06.2016 referred above, subject to submission of other prescribed documents and verification about the actual use of such other wastes by the actual users. The authorization so granted will be cancelled in case the actual user units, on behalf of which the import is intended by the trader, fail to obtain specific authorization for utilization from the Board within one month after issue of SOPs by CPCB for utilization of such waste and actual user unit of "Other Wastes" will also apply to CPCB through this Board within 15 days for approval to utilize the "Other Wastes" as resource and for developing the standard operating procedures for the same. Public notice has already been issued in the leading newspapers on 11.02.2018 in this regard.

After consideration of all the issues and requirements and to stream line the procedure further, some amendments has been made in the procedure and check list of the documents required to submit alongwith application for obtaining the onetime authorization by the trader unit to import the other waste on behalf of actual users under Rule 13 of HOWM Rules, 2016, which is given at **Annexure-III.**

The proposal is placed before the Board for consideration and approval of the above said procedure given at **Annexure-III** and for Ex-Post Facto delegation of the powers to the Chairman of the Board for grant/refusal of onetime authorization to the trader units desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users under Rule 13 of the said Rules.

The ministry of Environment, Forest & Climate Change, Govt. of India has notified Hazardous & Other Waste (Management & Trans-boundary Movement) Rules, 2016 on 4th April, 2016 in supersession of the Hazardous Waste (Management Handling & Trans-boundary Movement) Rules, 2008.

Every trader desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users, is required to obtain the authorization from the State Pollution Control Board under section 13 of the above said Rules.

Procedure for obtaining one time authorization by the trader units desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users.

Every trader desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users of the same, shall apply for obtaining one time authorization from the State Pollution Control Board under section 13 of the above said Rules to the concerned Regional Officer of the Board on prescribed Form-7 as per **Annexure-A** alongwith the documents mentioned in the check list of documents as per **Annexure-B**.

The Regional Officer will examine the application submitted by such traders and will submit the same complete in all respect including detail about type and quantity of other wastes, for which authorization has been sought for import, used by the actual users mentioned in the application as per their record and documents submitted by the unit alongwith his recommendation to Head Office within 15 days. In case of any incompletion in the application RO will get the application completed at his level within the period of 15 days after receipt of the application.

The concerned Branch in Head Office will examined the recommendation of the Regional Officer and will ensure that the application is decided within period of 15 days after receipt of the application in Head Office. The overall time period taken for deciding the application should not exceed 30 days in any case.

After commencing of online system for processing the applications for grant of one time authorization to the traders desirous of import of other wastes (* *) as listed in Part-D of Schedule-III of Hazardous & Other Waste (M&TM) Rules, 2016, on behalf of actual users of the same, shall be received and processed only through online system.

Construction of multi storey residential complex of Boards employees at GH-5, Sec-23, Panchkula

The Haryana Urban Development Authority (HUDA) allotted a plot of 6012 sq. mtr. (1.5 acres) to HSPCB for the construction of multi-story residential complex for employees of the Board at GH-5, Sec-23, Panchkula. The work of construction for residential complex, including approval for the building plans/drawing has been assigned to Haryana State Agriculture marketing Board on turnkey basis vide letter No. 2593 dated 07.04.2014.

The matter regarding change in size of dwelling units was examined in view of revised norms fixed by the Architecture Department, Haryana vide their Memo No. Arch-2014/SA-II/6682-6989 dated 04.06.2014 and accordingly, the proposal was sent to Estate Officer, HUDA letter No. 2890 dated 23.7.2014 (Annexure-'A') for according revised approval as per latest norms fixed by Architecture Department, Haryana and ex-post facto approval of Board was taken in its 172nd meeting held on 17.8.2014 vide resolution No. 172.14.

The revised sanction has been received from the Estate Officer, HUDA. The HUDA has accorded the revised sanction vide letter No. 2786 dated 15.03.2016 (Annexure-'B'). Accordingly, HSAMB was requested vide letter No. 10116 dated 17.03.2016 to submit the fresh building plan/drawing as per the revised sanction received from HUDA. Sh. Avinash Khosla, Architect (on behalf HSAMB) prepared fresh building plan of the residential complex as per the revised sanction received from HUDA and same were approved by HUDA vide memo No. 8437 dated 10.11.2017 (Annexure-'C'). In this project provision has been made for construction of following dwelling units:-

- 1. Construction of category B type 12 nos. dwelling units having area of 1800 Sqft each.
- 2. Construction of category C type 12 nos. dwelling units having area of 1400 Sqft each.
- 3. Construction of category D type 60 nos. dwelling units having area of 800 Sqft each.

Further, Chief Administrator, Haryana State Agriculture Marketing Board (HSAMB) was requested vide letter No. HSPCB/2017/1142 dated 22.12.2017 for submitting the detailed estimate of the residential project. HSAMB has submitted the detailed estimated of the project through its Executive Engineer. The total estimated cost of construction of dwelling units is Rs.320378400/- (Thirty Two Crores Three lakh Seventy Eight Thousand Four Hundred Only)(Annexure-D)

The matter regarding providing of common facilities in the proposed residential complex was discussed in the meeting held on 07.11.2017 under the chairmanship of Smt. Dheera Khendewal, IAS the then Chairman, HSPCB. It was decided to construct the common facilities for the residents like gathering hall for about 400 capacity and other activities to unitize the FAR and ground coverage. HSAMB has already been asked to prepare the drawings/plans of the common facilities.

Proposal is submitted before the Board for sanction of administrative approval for the construction of residential complex (dwelling units) for the employees of the Board at G-5, Sector-23, Panchkula for an estimated cost of Rs.320378400/- (Thirty Two Crores Three Lakh Seventy Eight Thousand Four Hundred Only) and administrative approval for the construction of common facilities will be taken later on after the receipt of estimate from HSAMB.

THIS REVISED ROUGH COST ESTIMATE FOR THE WORK CONSTRUCTION OF HSPCB RESIDENTIAL COMPLEX AT GH-5, SECTOR-23, PANCHKULA HAS BEEN FRAMED IN THE OFFICE OF EXECUTIVE ENGINEER (P), HSAMB, KISAN BHAWAN, SECTOR-14, PANCHKULA.

HISTORY & REPORT:-

The administrative approval for the work cited above for amounting to Rs. 1547.30 lacs was accorded by the competent authority of HSPCB and conveyed to this office vide memo no. 519 dated 30.11.2007. The Architects Avinash Khosla & Associates, Ludhiana (M.No. 98140-21780) and e-mail ID kanavkhosla@consultant.com was engaged for design and drawing for this work. After completing the formalities of tender, the work was allotted to M/s Pacific Project Ltd., Parshant Vihar, Delhi-85 vide memo no. 1415 dated 29.04.2008. But, the agency was not satisfied with the allotted rates and he gave his objections/undertaking on 26.05.2008 to the then XEN and the objections/observations were considered by the TAC meeting held on 16.06.2008. The quoted rates of the agency were approved by the then Chief Engineer on 17.06.2008 and again amended allotment letter was given to the agency vide this office memo no. 1749 dated 20.06.2008. The work was started at site but the same was stopped due to non availability of HUDA approved drawings from the concerned Department (HSPCB) as the land was allotted to the HSPCB from HUDA. The matter was decided to finalize the agency in the meeting held under the chairmanship of Chief Administrator HSAMB on 09.10.2009 and to release EMD of the agency. Accordingly, the agency was finalized for the work as executed by him and EMD was got released.

Thereafter, agency has gone into the Hon'ble Punjab & Haryana High Court Chandigarh for appointment of Arbitrator. The Hon'ble High Court has appointed the Sole Arbitrator, Sh. Kuldeep Singh, Chief Engineer (Retd.), PWD B&R, Punjab. The Arbitrator has announced arbitration award in favour of agency. The Board has challenged the award in District Court, Panchkula on 12.07.2017. The District Court Panchkula has transferred the case to Ld. Special Commercial Court at Gurugram for the further proceedings, due to commercial dispute of specified value beyond Rs.1 Crore and the proceeding of the same in Hon'ble Court in Gurugram is in process.

The preliminary sketch of 90 nos. dwelling units were approved by the Chairman of HSPCB and same was circulated to HSAMB vide memo no. HSPCB/2016/793 dated 24.11.2016. On the basis of these drawings the consultant has submitted revised rough cost estimate amounting to Rs.32.00 Crore for 84 dwelling units and same was submitted in Circle Office vide this office memo no.428 dated 29.05.2017. The estimate was returned to Division Office with some observations. The estimate was submitted in the Circle Office vide this office memo no. 566 dated 27.06.2017 after making compliance. But again observations were raised by Circle Office vide memo no. SE(P)-2017/1289 dated 1.07.2017 and the estimate was re-submitted vide this office memo no. 637 dated 17.07.2017 after making compliance. But the same estimate returned to this office with request to re-submit the same within two days after correction in the estimate as discussed with SDO/XEN of Division Office as the consultant has taken 70% price escalation without any reason. The estimate prepared on basis of plinth area of PWD B&R norms amounting to Rs.27.74 Crore was submitted to Circle Office, Panchkula vide this office memo no.708 dated 28.07.2017. The

estimate was checked in Circle Office and sent to the Chief Engineer, H.S.A.M. Board Office amounting to Rs.32.62 Crore due adding of price escalation and Departmental charges. The estimate was returned back to this office with remarks that "add approved drawings from DTP/HUDA & also prepare rough cost estimate on these drawings."

The Chairman of HSPCB has re-approved the layout plan on 24.11.2016 as prepared by Consultant already appointed by HSAMB. On the basis of layout plan, the Consultant has submitted the detailed drawings in HUDA through HSPCB. The HUDA approved drawings were received through HSPCB vide memo no. HSPCB/2017/1142 dt 22.12.2017. A meeting was held on 07.11.2017 under the Chairmanship of Smt. Dheera Kandelwal, I.A.S. Chairman of HSPCB and it was decided to construct a gathering/community hall with basement of about 400 capacity + 4 to 5 Rooms for Common facilities in the residential colony. The estimate was prepared by the consultant as per approved drawings by the consultant and submitted for amounting to Rs.34.62 Crores including the cost of gathering/community hall. Now, the revised rough cost estimate has been prepared as per plinth area norms basis of PWD (B&R) for the above said work amounting to Rs.33.37 Crore is submitted containing part-(A) Staff Flats costing to 32.62 Crore and Part-(B) Community Centre of Rs.0.75 Crore for approval from the competent authority of HSPCB being Deposit Work with HSAMB. In the estimate 5% Departmental charges are also headed.
