In this connection, I have been directed to enclose herewith the proceedings of meeting under the Chairmanship of Chief Secretary, Haryana held on 03.12.2025 at 01:00 PM in CS Committee Room, 4<sup>th</sup> floor, Haryana Civil Secretariat, Chandigarh to review the Drainwise Yamuna Action Plan for your information and necessary action please.

Subject:- Minutes of meeting held under the Chairmanship of Sh. Anurag Rastogi, IAS, Chief Secretary, Haryana on 03.12.2025 at 01:00 PM in the Main Committee Room, Haryana Civil Secretariat-1, 4th floor, Chandigarh to review the drain wise Yamuna Action Plan.

The list of the participants is as per Annexure-1.

At the outset, Chief Secretary welcomed all the participants and expressed his concern to control pollution in river Yamuna and improve its water quality. He informed that even the Vice President and Union Urban Affairs Minister are concerned about river Yamuna. He emphasized the importance of implementation of drain wise Yamuna action plan in a time bound manner. He stressed that every officer should make his target to achieve the desired results to improve the water quality of river Yamuna in a time bound manner. HSPCB informed that a meeting was held under the Chairmanship of Hon'ble Home Minister, Government of India on 19.09.2025, wherein it was decided that Action Plan prepared by State of Haryana should be redrafted drain wise. In pursuance to the said decision, meetings were held under Addition Chief Secretary, Environment Department and Chief Secretary, Haryana on 23.09.2025, 27.10.2025 & 14.11.2025, wherein, Nodal Officers of the concerned departments were directed to go through the data with respect to quantity of treated / untreated effluent in each drain, number & capacity of existing STPs/CETPs, under construction STPs/CETPs, number of tapping points identified by the departments and number of industries, their discharge and treatment of trade effluent and interaction may be made with the departments to complete all the details. Based on the detailed survey/information/data, provided by the Nodal Officers, a Comprehensive Drain Wise Action Plan For mitigation of pollution in River Yamuna has been prepared. Now, the meeting is being convened to ask all the Nodal Officers of the departments to present drain wise details with respect to action points, existing STPs/CETPs, under construction STPs/CETPs, proposed STPs/CETPs quantity of treated/untreated effluent of each point source falling into each drain and prepare more elaborative Action Plan for tapping all effluent discharge points of various areas/towns.

During the meeting, PHED informed that there are 36 villages where micro STPs are required to be installed but there is no provisions of funds with the departments as such these STPs could not be installed. Earlier, HSPCB has been requested to provide the funds amounting to Rs. 100 crores from Environment Compensation funds collected by HSPCB from the violating units/industries. Chief Secretary desired that this issue be placed before the committee for allotment of Environment Compensation funds.

Thereafter, the Nodal Officers of the concerned departments gave presentation with respect to each drain mentioning the details of above points and also gave timelines for tapping all the effluent discharge points. They further informed that they have made survey but still there may be clandestine inlets in the beds of the drains which may get exposed as and when the flow quantities in the drains recedes after tapping of already identified effluent discharges.

Nodal Officer for Leg-I drain informed that he has identified effluent discharge point of Udhyog Vihar which belongs to HSIIDC. Managing Director, HSIIDC assured that he shall obtain the details of the discharge point and appropriate action shall be taken accordingly. Nodal Officer for KCB drain informed that he has got conducted meeting at the level of Deputy Commissioner for action plan. He also informed that MDU is not discharging any treated sewage and the same is reused within the campus. The Chief Secretary expressed his concern that any unit can reuse its treated effluent if it is

conforming to the prescribed standards. The Nodal Officer for Mungeshpur drain informed that the said drain enters in Jhajjar District carrying highly polluted effluent from Delhi area. Nodal Officer for drain no. 2 informed that there is lot of industrial effluent in drain no. 2 and some of the CETPs are inadequate. HSPCB informed that there are 3 CETPs (21 MLD, 21 MLD and 2.5 MLD) in Panipat and one more CETP is under proposal. ACS, Department of Urban Local Bodies expressed his concern that issue of 21 MLD CETP was got approved on urgent basis but the long time taken for its installation is not a healthy sign. MD, HSIIDC assured that he will look into the issue on priority basis.

Engineering —in- Chief, department of Irrigation raised the issue of monthly milestone for achieving the objective in each project of the action plan regarding construction of STPs/CETPs/lying of sewerage network etc.

General Manager, HSIIDC, raised the issue of funds of Rs. 875 Crore for CETPs of Faridabad. He also raised the issue of land for CETPs in Gurugram. The Chief Secretary expressed his concerned regarding keeping this issue pending for longtime. Additional Chief Secretary, Town and Country Planning Department informed that though the area stands transferred to HSIIDC but even if any issue is still pending, the file will be put up for any appropriate decision in the matter

Sh. J.P. Singh, SEE, HSPCB informed that online monitoring devices (OMDs) have not been installed at many STPs/CETPs and the data is not being displayed of many units. The department wise details are annexed as per **Annexure-2 & 3**. He further informed that in the meeting held under ACS, Environment, it has been decided that CETP of HSIIDC at Refinery Road Panipat be made operational and in order to utilize the said CETP, as a temporary arrangements, the industries which have not installed their individual ETPs, their effluent may be transported to CETP for treatment till the CETP receives effluent from the industries set up in the industrial area.

There is mandate from Haryana Vidhan Sabha to set up a control room in HSPCB for CCTV installed on STPs and to monitor the footage of these cameras. The Chief Secretary desired that HSPCB should install control room and data may be displayed within 4-6 weeks and it may be made main agenda for the next meeting onwards.

The matter regarding installation of 30 MLD STP Rathdhana, Sonipat was also discussed in the meeting and it was informed that the tendering process is in line for long time. The Chief Executive Officer, SMDA informed that the rates quoted in the tender are very high and the department has already written for financial evaluation and the matter shall be resolved as soon as possible.

After detailed deliberation in the matter, the Chief Secretary, Haryana decided as under:-

- 1. Each of the 11 drains falling into river yamuna shall be visited by each Nodal Officer from starting point to its end within 7 days.
- 2. HSPCB shall constitute committees of the concerned departments of the Districts under the Chairmanship of Divisional Commissioner Ambala, Karnal, Gurgaon, Rohtak and Faridabad to monitor the action points and progress with regard to action plan.
- 3. DO Letter be got written by HSPCB from Chief Secretary, Haryana to all the Divisional Commissioners of the Divisions namely Ambala, Karnal, Gurgaon, Rohtak and Faridabad regarding control of pollution in River Yamuna.

- 4. All the Divisional Commissioners of Divisions namely Ambala, Karnal, Gurgaon, Rohtak and Faridabad shall hold 03 meetings in a month with the duration of 10 days and minutes of the meeting/progress on all the issues be submitted to Chairman, HSPCB.
- 5. Chairman, HSPCB and Additional Chief Secretary, Environment Department shall hold meeting with all the concerned departments before 5<sup>th</sup> of each month to monitor the action plan.
- 6. The Chief Secretary of Haryana shall also hold meeting with very senior officer of concerned departments before 9<sup>th</sup> of each month with all the concerned departments to review the drain wise Yamuna Action Plan.
- 7. HSPCB shall place agenda before the committee to release funds to PHED for installation of micro STPs of villages along Yamuna to treat their waste water.
- 8. As discussed in the meeting, Mungeshpur drain enters in Jhajjar District carrying highly polluted effluent from Delhi area. Therefore, it was decided that DO letter may be got written from CS, Haryana to CS, Delhi to take early steps to control pollution from Delhi area entering into Mungeshpur drain.
- 9. MD, HSIIDC shall take immediate action to curtail effluent discharge from Udhyog Vihar Delhi, so that it may not enter into Leg-I drain
- 10. The treated effluent of the units, conforming to the prescribed standards may be reused for various usages.
- 11. Additional Chief Secretary, Town and Country Planning Department shall take immediate steps for arrangements of funds of Rs. 875 Crore for CETPs of Faridabad area and land issue for CETP may also be resolved in a time bound manner.
- 12. HSPCB shall install control room for monitoring of data of OMDs and footage of CCTV cameras and data may be displayed within 4-6 weeks and it may be made main agenda for the next meeting onwards.
- 13. CEO, SMDA shall resolve the issue of tendering process for installation of 30 MLD STP at Rathdhana, Sonipat and the same may be got installed in a time bound manner.
- 14. HSPCB shall carry out detailed sampling of each drain at the boundary of the District entering in their jurisdiction and the District Authorities may be informed about the source of effluent. Necessary instructions may be issued by HSPCB.
- 15. CETP of HSIIDC at Refinery Road Panipat be made operational and in order to utilize the said CETP, as a temporary arrangements, the industries which have not installed their individual ETPs, their effluent may be transported to CETP for treatment till the CETP receives effluent from the particular industries set up in the industrial area.
- 16. HSIIDC shall take immediate steps to install 21 MLD STP at Panipat so as to treat the industrial wastewater of the area.

The meeting ended with vote of thanks to the chair and all other participants.
